Craven District Council is registered as a data controller under the Data Protection Act 1998. This privacy notice explains why we ask you for personal information when you apply to use any of our services, and how we will use the information that you have provided.

What information we collect about you

We collect information about you when you apply for a car parking permit, including your name and contact information including home, email addresses, telephone numbers and vehicle registration number.

How we will use the information we have obtained from you

We require this information for the following reasons and to provide you with a better service, in particular:

- Your contact details are needed in case there is any query about your car parking permit.
- From time to time we may use your information to contact you regarding information about the other services that the Council offers or for market research purposes. None of your information will be shared with third parties for these purposes. If you agree to this, we may contact you by email, telephone/text message or letter.
- We may use your information for statistical purposes, for example to assess use of the Council's car parks. Statistics are used in such a way that individuals cannot be identified from them.
