- 1. <u>Purpose of Report</u> The purpose of this report is to enable the Council to calculate and approve the Council Tax requirement for 2021/22.
- **2. Recommendations** Members are recommended to:
- 2.1 It be noted that on 20th October 2020 the Council calculated the Council Tax Base 2021/22
 - (a) for the whole Council area as 22,362.93 [Item T in the formula in Section 33 of the Local Government Finance Act 1992, as amended by the Localism Act 2011 (the "Act")]; and
 - (b) for dwellings in those parts of its area to which a Parish precept relates as in the attached Appendix A.
- 2.2 Calculate that the Council Tax requirement for the Council's own purposes for 2020/21 (excluding Parish precepts) is £4,074,749.
- 2.3 That the following amounts be calculated for the year 2021/22 in accordance with Sections 31 to 36 of the Act:
 - (a) £24,968,357 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(2)a of the Act taking into account all precepts issued to it by Parish Councils.
 - (b) £19,941,596 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(3)a of the Act.
 - (c) £5,026,761 being the amount by which the aggregate at (a) above exceeds the aggregate at (b) above, calculated by the Council in accordance with Section 31A(4) of the Act as its Council Tax requirement for the year. (Item R in the formula in Section 32(4) of the Act).
 - (d) £224.78 being the amount at (c) above (Item R), all divided by Item T (2.1(a) above), calculated by the Council, in accordance with Section 33(1) of the Act, as the basic amount of its Council Tax for the year (including Parish precepts).

- (e) £1,439,790 being the aggregate amount of all special items (Parish precepts) referred to in Section 34(1) of the Act (as per the attached Appendix B).
- (f) £182.21 being the amount at (d) above less the result given by dividing the amount at (e) above by Item T (2.1(a) above), calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no Parish precept relates.
- 2.4 To note that the County Council, the Police and Crime Commissioner and the Fire and Rescue Service have issued precepts to the Council in accordance with Section 40 of the Local Government Finance Act 1992 for each category of dwellings in the Council's area as indicated in the table below.

That the Council, in accordance with Sections 30 and 36 of the Local Government Finance Act 1992, hereby sets the aggregate amounts shown in the tables below as the amounts of Council Tax for 2021/22 for each part of its area and for each of the categories of dwellings.

2.7 To note the Council's Council Tax Reduction Scheme for 2021/22 remains unchanged as detailed in paragraph 7.9 of the Revenue Budget 2021/22, reported to Policy Committee on 2nd February 2021.

3. Report

- 3.1 The Localism Act 2011 has made significant changes to the Local Government Finance Act 1992, and now requires the billing authority to calculate a Council Tax requirement for the year, not its budget requirement as previously.
- 3.2 The precept levels of other precepting bodies have been received. These are detailed below:

3.3 Town & Parish Councils

The Town & Parish Council Precepts for 2021/22 are detailed in Appendix A and total £1,439,790. The increase in the average Band D Council Tax for Town and Parish Councils is 1.52% and results in an average Band D Council Tax figure of £64.38 for 2021/22 (£63.62 2020/21).

3.4 North Yorkshire County Council

North Yorkshire County Council met on 17th February 2021 and set their precept at £31,555,212. This results in a Band D Council Tax of £1,411.05 for 2021/22 (£1,363.47 2020/21).

3.5 Police and Crime Commissioner North Yorkshire

Police and Crime Commissioner North Yorkshire met on 5th February 2021 and set their precept at £6,061,696 adjusted, by a Council Tax Collection Fund contribution of £(17,547). This results in a Band D Council Tax of £271.06 for 2021/22 (£265.77 2020/21).

3.6 North Yorkshire Fire and Rescue Service

North Yorkshire Fire and Rescue Service met on 5th February 2021 and set their precept at £1,657,988 adjusted, by a Council Tax Collection Fund contribution of £4,799. This results in a Band D Council Tax of £74.14 for 2021/22 (£72.69 2020/21).

3.7 This action flows from the approval of the budget. The wording of the recommendations are largely prescribed.

4. Financial and Value for Money Implications

4.1 The District Council's element of the Council Tax has been increased by £5 compared to last year's Band D amount and applied pro rata to all other bands.

5. Legal Implications

- 5.1 The Council has a statutory requirement to set the Council Tax for the 2021/22 financial year by 11th March 2021 in accordance with the Local Government Finance Act 1992.
- This ties in with the need to agree a balanced budget. In addition, there are requirements in Section 25 of the Local Government Act 2003 for reports to be presented to the Council on the robustness of the estimates, and on the position on reserves and balances. These matters were covered in the report to Policy Committee on the 2nd February 2021.

6. Contribution to Council Priorities

6.1 None arising directly from this report.

6.2 Impact on the declared Climate Emergency

Setting a Council Tax level to allow service provision without significant investment from the Council's own reserves, will allow for investment in future developments and projects that will contribute to a reduced Carbon Footprint.

7. Risk Management

7.1 If the Council does not set the Council Tax for 2021/22 by 11th March 2021 it will be in breach of its statutory duty.

7.2 Chief Finance Officer (s151 Officer) Statement

The report formally sets out the calculations and elements making up the total Council Tax levels to be collected, as required by statute. The council's proposed level of Council Tax increase has been assumed in the budget calculations for 2021/22.

7.3 Monitoring Officer Statement

It is a Council function to determine the level of Council Tax and to set a balanced budget.

8. Equality Impact Assessment - The Council's Equality Impact Assessment
