# **Monitoring Discussion Papers Nos 2-4**

Report of the Strategic Manager for Planning and Regeneration

#### 1. Purpose of Report

1.1 To present to members of this sub-committee three Monitoring Discussion Papers (MDPs) relating specifically to the following themes of the Council's Climate Emergency Strategic Plan (CESP): Travel & Transportation (MDP No 2)

Land & Nature (MDP No 3) Carbon Neutral Energy and Low Carbon Waste (MDP No 4)

- 2. Recommendations Members are recommended to:
- 2.1 Consider the three Monitoring Discussion Papers and appendices attached to this report to initiate a discussion between the Spatial Planning Team and members of this sub-committee relating to the ongoing monitoring and review of the adopted Craven Local Plan.

#### 3. Report

- 3.1 As agreed by this sub-committee, the first set of MDP's are to focus on the Council's CESP. The CESP is an important changed circumstance which will need to be taken into account in the monitoring and review of the Craven Local Plan. The CESP themes that relate to the Craven Local Plan are:
  - 1. Carbon neutral development
  - 2. Travel and Transportation
  - 3. Land and Nature
  - 4. Carbon Neutral Energy and Low Carbon Waste.
- 3.2 Members will recall that the first MDP related to the theme of carbon neutral development and was presented to this subcommittee on the 10<sup>th</sup> November 2020. Following this, a number of workshops were arranged with all members and the Council's Development Management Team to look at how relevant adopted Craven Local Plan policies can be fully implemented to help achieve carbon neutral development and how the local plan can be updated to contribute further to the Council's commitment to a carbon neutral Craven by 2030.

- 3.3 The second, third and fourth MDPs now presented to this subcommittee relate to the remaining themes of the CESP, linked to the Craven Local Plan.
- 3.4 As with the first MDP, the following discussion points are suggested for each of the three MDPs presented:
  - **Existing Policies** How existing Local Plan policies support the specific theme and how they can be implemented to achieve optimum results now.
  - Future Policies How existing policies can be improved (through a review and update of the Local Plan) to achieve better results for the specific theme in the future.
  - **Requirements and Limitations** What evidence we need to support future Local Plan policies and what limitations are imposed, on the Local Plan, by national planning policy.
- 3.5 It is considered appropriate to present and discuss the three MDPs together, as each theme and relevant adopted local plan policies are closely linked.
- 3.6 This collaborative working between officers and members undertaken as part of the ongoing monitoring and review of the adopted Craven Local Plan will help to gradually build up a picture of any changing circumstances affecting the area, and how the local plan and associated evidence base may need updating in the future. This work will contribute to achieving the Government's requirement for monitoring and review of the Craven Local Plan to be completed no later than November 2024. It is hoped that this work will also feed into subsequent reviews of the Council's Climate Emergency Strategic Plan 2020-2030.

#### 4. Financial and Value for Money Implications

4.1 None arising directly from this report, however there will be costs in respect to monitoring, review and updating of the Craven Local Plan.

#### 5. Legal Implications

- 5.1 This work forms part of the monitoring and review process for the adopted Craven Local Plan, which must continue to fulfil the following legal requirements:
  - Regulation 10A of The Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended), which requires local planning authorities to review local plans and Statements of Community Involvement at least once every 5 years from their adoption date to ensure that policies remain relevant and effectively address the needs of the local community;
  - Section 19(1A) of the Planning & Compulsory Purchase Act 2004, which imposes a legal duty to ensure that climate change mitigation and adaptation are integrated as core objectives across all local plan policies; and
  - Strategic Environmental Assessment Regulations, which impose an obligation to assess the consistency of local plan policies with wider climate change objectives.

## 6. Contribution to Council Priorities

- 6.1 The adopted Craven Local Plan, its review and any necessary updates will contribute to all the Council's Priorities.
- 6.2 **Impact on the declared Climate Emergency:** The Local Plan supports the themes of the Council's CESP listed in paragraph 3.1 of this report. The first four MDPs presented to members are tools to aid discussion around the ongoing monitoring and review of the adopted Craven Local Plan, specifically relating to how the adopted local plan currently contributes towards achieving a carbon neutral Craven by 2030 and how it could be updated to further contribute to achieving this aim. Therefore, the report and recommendation should have a positive impact on the declared Climate Emergency.

#### 7. Risk Management

7.1 The report sets out the steps the Council is required to take to comply with its legal duties to carryout ongoing monitoring and any subsequent updating of the adopted Craven Local Plan under the requirements set out at 5.1, above.

# A Evidence

**Final SA Report, November 2019** – Sustainability Appraisal (SA) is a legal requirement and provides evidence to show how the Local Plan's spatial strategy, housing growth, policies and site allocations will make a positive contribution towards the achievement of sustainable development.

**Climate Emergency Strategic Plan 2020-2030** – The Council has pledged to make the District carbon neutral by 2030 and has set out specific actions in a Strategic Plan. A number of actions are supported by the Local Plan, including five under the theme of Travel and Transportation: TRT01 EV Charging Network, TRT02 EV Charging in Developments, TRT03 Safer Walking and Cycling Network, TRT05 Improve Car-free access to Skipton, TRT06 A coordinated approach to Public Transport improvement.

**Infrastructure Delivery Plan** – The IDP assesses existing infrastructure provision in Craven, considers what new infrastructure needs will arise from implementation of the Local Plan and determines how these will be met.

**Viability Assessment** – The VA assesses the financial implications of Local Plan policy requirements and provides evidence to show that the viability of development will not be undermined and delivery of the Local Plan can therefore be achieved.

# **B** Policy

**SP2: Economic Activity and Business Growth** – This policy supports enhanced walking, cycling and public transport and therefore supports actions TRT03, TRT05 and TRT06.

**ENV7: Land and Air Quality** – This policy requires development to encourage walking and cycling; encourage the use of public transport and electric vehicles; and reduce car-use and emissions. It therefore supports actions TRT01, TRT02, TRT03 and TRT05.

**INF4: Parking Provision** – This policy promotes low emission vehicles, electric vehicle charging points and cycle parking. It therefore supports actions TRT01, TRT02, TRT03 and TRT05.

**INF7: Sustainable Transport and Highways** – This policy seeks improvements in public transport, cycling and walking. It therefore supports actions TRT03, TRT05 and TRT06.

A further four policies support actions TRT03 and TRT05; and a further 11 support TRT03 only. See Appendix B for full details.

# **C** Supplementary Planning Documents

**Good Design in Craven** – This will cover sustainable design, designing new urban environments and public realm, connecting places and ensuring good accessibility and will therefore provide further support to actions TRT01, TRT02, TRT03 and TRT05.

# D Changed Circumstances

**NPPF** – The 2012 National Planning Policy Framework (NPPF) was the basis for preparation and examination of the Local Plan. However, the revised NPPF of June 2019 now applies.

**Climate Emergency** – In 2019, after the Local Plan had been submitted and the examination was nearing its conclusion, the Council declared a climate emergency.

**2030 Petrol and Diesel Deadline** – In 2020, the government brought forward the deadline for ending the sale of new petrol and diesel cars and vans from 2040 to 2030.

# E Monitoring Data

**Authority Monitoring Report** – the Council's latest AMR covers the monitoring year of April 2019 to March 2020, during which the Craven Local Plan (adopted November 2019) was in operation for approximately 5 months. There are no monitoring indicators relating specifically to the Local Plan's support for actions under the Travel and Transportation theme of the Climate Emergency Strategic Plan. However, **Indicator Inf-2** does monitor the delivery of projects or schemes identified in the Infrastructure Delivery Plan. The AMR reports that no such projects or schemes were required/delivered during the last monitoring period.

# **F** Issues

**Evidence Base** – The latest SA, IDP and VA support the current Craven Local Plan, but further work will be required to support any future update, subsequent to a Plan review. As the current Plan predates the Climate Emergency Strategic Plan, the existing evidence base does not address the Travel and Transportation theme directly.

**Changed Circumstances** – The fact that the Local Plan was prepared and examined under the 2012 NPPF is not a significant issue and the 2019 NPPF is taken into account in planning decisions as a 'material consideration'. Due to timing, the Council's climate emergency declaration could not be taken into account during the Local Plan process. However, the Plan does fulfil legal requirements to contribute to the mitigation of and adaptation to climate change. As a result of the government's recent decision, the petrol and diesel deadline has now been brought within the time frame of both the Local Plan (2012-2032) and Climate Emergency Strategic Plan (2020-2030).

**Monitoring Data** – Currently, there is only about 5 months of monitoring data for the Craven Local Plan and no monitoring indicators relate specifically to the Local Plan's support for actions under the Travel and Transportation theme of the Climate Emergency Strategic Plan.



# A Evidence

**Final SA Report, November 2019** – Sustainability Appraisal (SA) is a legal requirement and provides evidence to show how the Local Plan's spatial strategy, housing growth, policies and site allocations will make a positive contribution towards the achievement of sustainable development.

**Climate Emergency Strategic Plan 2020-2030** – The Council has pledged to make the District carbon neutral by 2030 and has set out specific actions in a Strategic Plan. A number of actions are supported by the Local Plan, including six under the theme of Land and Nature: LAN01 Increase Tree Cover across Craven, LAN02 Increase Tree Cover across our estate, LAN03 DNAire, LAN05 Diversify Land Use, LAN06 Woodland Memorial Site, LAN07 Promote native species.

**Biodiversity** – The Craven Biodiversity Action Plan provides information and identifies actions that can be undertaken to conserve the District's biodiversity. The Craven BAP Action Programme provides a table of targets and actions for making progress towards the Craven BAP objectives. The UK BAP formed the overarching strategy for local action plans, including the Craven BAP.

**Green Infrastructure** – The Leeds City Region Green and Blue Infrastructure Strategy sets out the vision for GI and future investment. The LCR Infrastructure Map is an online map of the region's infrastructure, including GI. The Yorkshire and Humber GI Mapping Project provides evidence to support projects and policy within the LCR.

**Viability Assessment** – The VA assesses the financial implications of Local Plan policy requirements and provides evidence to show that the viability of development will not be undermined and delivery of the Local Plan can therefore be achieved.

# **B** Policy

**ENV4: Biodiversity** – This policy requires a net gain in biodiversity and an increase in trees and woodland, wherever possible, and identifies specific allocated sites where net gains in biodiversity will be required. It therefore supports actions LAN01, LAN03 and LAN07.

**ENV5: Green Infrastructure** – This policy requires improvement and expansion of the GI network, wherever possible, and identifies specific allocated sites where improvements and growth in GI will be required. It therefore supports actions LAN01, LAN03 and LAN07.

**EC3: Rural Economy** – This policy supports innovation, land-based businesses and the use of farmland/buildings in new and different ways. Examples include green technology, renewable and low-carbon energy, flood management and research. It therefore supports actions LAN01, LAN02, LAN05, LAN06 and LAN07.

A further ten policies support actions LAN01 and LAN07; a further two support LAN03; and a further two support LAN05. See Appendix B for full details.

# **C** Supplementary Planning Documents

**Biodiversity and Green Infrastructure** – This will cover the provision of biodiversity net gain as part of new developments, and the appropriate provision of green infrastructure using native species, both within a site and forming linkages to other green infrastructure assets where possible, and will therefore provide further support to actions LAN01, LAN03 and LAN07.

# D Changed Circumstances

**NPPF** – The 2012 National Planning Policy Framework (NPPF) was the basis for preparation and examination of the Local Plan. However, the revised NPPF of June 2019 now applies.

**Climate Emergency** – In 2019, after the Local Plan had been submitted and the examination was nearing its conclusion, the Council declared a climate emergency.

# E Monitoring Data

**Authority Monitoring Report** – the Council's latest AMR covers the monitoring year of April 2019 to March 2020, during which the Craven Local Plan (adopted November 2019) was in operation for approximately 5 months. There are no monitoring indicators relating specifically to the Local Plan's support for actions under the Land and Nature theme of the Climate Emergency Strategic Plan. However, **Indicator Ec-15** does monitor the number and type of approvals for tourism development, which would include any linked to the DNAire project (action LAN03). The AMR reports that three tourism developments were approved during the last monitoring period, but none have links to DNAire.

## **F** Issues

**Evidence Base** – The latest SA and VA support the current Craven Local Plan, but further work will be required to support any future update, subsequent to a Plan review. As the current Plan predates the Climate Emergency Strategic Plan, the existing evidence base does not address the Land and Nature theme directly.

**Changed Circumstances** – The fact that the Local Plan was prepared and examined under the 2012 NPPF is not a significant issue and the 2019 NPPF is taken into account in planning decisions as a 'material consideration'. Due to timing, the Council's climate emergency declaration could not be taken into account during the Local Plan process. However, the Plan does fulfil legal requirements to contribute to the mitigation of and adaptation to climate change.

**Monitoring Data** – Currently, there is only about 5 months of monitoring data for the Craven Local Plan and no monitoring indicators relate specifically to the Local Plan's support for actions under the Land and Nature theme of the Climate Emergency Strategic Plan.



**Final SA Report, November 2019** – Sustainability Appraisal (SA) is a legal requirement and provides evidence to show how the Local Plan's spatial strategy, housing growth, policies and site allocations will make a positive contribution towards the achievement of sustainable development.

**Climate Emergency Strategic Plan 2020-2030** – The Council has pledged to make the District carbon neutral by 2030 and has set out specific actions in a Strategic Plan. A number of actions are supported by the Local Plan, including five under the themes of Carbon Neutral Energy and Low Carbon Waste: CNE06 Renewable Energy for CDC Operations, CNE07 Low Carbon Rural Development, CNE08 High Planning Standards for Energy, CNE09 Support and Promote Renewable Energy, LCW05 Anaerobic Digestion Facilities.

**Renewable and low carbon energy evidence** – relevant Local Plan policies are supported by three evidence-base documents: Low Carbon and Renewable Energy Capacity in Yorkshire and Humber (2011), Managing Landscape Change (2012) and the Forest of Bowland AONB Renewable Energy Position Statement (2011).

**Viability Assessment** – The VA assesses the financial implications of Local Plan policy requirements and provides evidence to show that the viability of development will not be undermined and delivery of the Local Plan can therefore be achieved.

# **B** Policy

**ENV3: Good Design** – This policy promotes sustainable design and construction and therefore supports actions CNE06, CNE07, CNE08 and CNE09.

**ENV7: Land and Air Quality** – This policy requires development to reduce emissions and therefore supports actions CNE06, CNE07, CNE08 and CNE09.

**ENV9: Renewable and Low Carbon Energy** – This policy supports projects and infrastructure, including wind, biomass and anaerobic digestion, and therefore supports actions CNE06, CNE09 and LCW05.

**EC3:** Rural Economy – This policy supports innovation, land-based businesses and the use of farmland/buildings in new and different ways, including for green technology and renewable and low-carbon energy. It therefore supports actions CNE09 and LCW05.

**EC4A: Tourism–Led Development at Bolton Abbey** – Draft proposals emerging under this policy include a biomass boiler, which would support action CNE09.

**Good Design in Craven** – This will cover sustainable design and construction and will therefore provide further support to actions CNE06, CNE07, CNE08 and CNE09.

# **D** Changed Circumstances

**NPPF** – The 2012 National Planning Policy Framework (NPPF) was the basis for preparation and examination of the Local Plan. However, the revised NPPF of June 2019 now applies.

**Climate Emergency** – In 2019, after the Local Plan had been submitted and the examination was nearing its conclusion, the Council declared a climate emergency.

# E Monitoring Data

Authority Monitoring Report – the Council's latest AMR covers the monitoring year of April 2019 to March 2020, during which the Craven Local Plan (adopted November 2019) was in operation for approximately 5 months.

**Indicator Ed-3** (number of non-residential developments of 1,000m<sup>2</sup> or more meeting BREEAM 'Very Good' standards) relates to the sustainable design and construction requirements of policy ENV3 s). In the last monitoring year, five developments of more than 1,000m<sup>2</sup> non-residential floor space were completed, but all were granted planning permission before adoption of the Craven Local Plan and none achieved a BREEAM rating of 'very good'.

**Indicator Ed-9** (planning permissions granted for renewable energy schemes) has been monitored since adoption of the Craven Local Plan and relates to the support provided by policies ENV9 and EC3. In the last monitoring year, no relevant planning permissions were granted.

#### **F** Issues

**Evidence Base** – The latest SA, VA and renewable and low carbon energy evidence support the current Craven Local Plan, but further work will be required to support any future update, subsequent to a Plan review. As the current Plan predates the Climate Emergency Strategic Plan, the existing evidence base does not address the Carbon Neutral Energy and Low Carbon Waste themes directly.

**Changed Circumstances** – The fact that the Local Plan was prepared and examined under the 2012 NPPF is not a significant issue and the 2019 NPPF is taken into account in planning decisions as a 'material consideration'. Due to timing, the Council's climate emergency declaration could not be taken into account during the Local Plan process. However, the Plan does fulfil legal requirements to contribute to the mitigation of and adaptation to climate change.

**Monitoring Data** – Currently, there is only about 5 months of monitoring data for the Craven Local Plan and monitoring indicators relate to some, but not all policy requirements relevant to the Carbon Neutral Energy and Low Carbon Waste themes.

# **Actions Relevant to Craven Local Plan Policies**

#### Theme: Carbon Neutral Development

**CND01 Zero Carbon Housing** 

Review the Council's development portfolio; identify and act on opportunities to move towards the Zero Carbon housing model

CND02 Zero Carbon Regeneration

Work with our Joint Venture partners to include energy efficient options in our construction plans wherever possible and ensure that our regeneration projects are as close to zero carbon as possible

CND03 Lower Carbon Planning

Work with developers as any new sites across Craven are approved to ensure that opportunities for efficiency and carbon reduction are maximised

#### **Theme: Travel and Transportation**

TRT01 EV Charging Network

Review the availability of charging points across the District and support the installation of a complete and coherent network, including installing EV charging points in Council car parks

TRT02 EV Charging in Developments

Require electric vehicle charging points linked to new buildings wherever possible

TRT03 Safer Walking and Cycling Network

Develop safe walking and cycling routes to ensure that the district is accessible for commuting and leisure

TRT05 Improve Car-free access to Skipton

Improve the Skipton Station area to ensure a higher proportion of journeys by train, continue to update Skipton's walking and cycling infrastructure and considering options for park & ride schemes

TRT06 A coordinated approach to Public Transport improvement

Implement a District transport plan containing a co-ordinated series of improvements to public transport into and around Skipton & The Dales, using Craven's network of railway stations as local travel hubs.

#### Theme: Land and Nature

LAN01 Increase Tree Cover across Craven

Supporting the Northern Forest scheme by supporting and accessing investment in tree planting across the District; Supporting large-scale planting by the Environment Agency and by the Woodland Trust

LAN02 Increase Tree Cover across our estate

Identifying opportunities for tree planting and increasing tree cover across Craven District Council's estate

LAN03 DNAire

Complete the DNAire biodiversity scheme

LAN05 Diversify Land Use

Craven District Council has declared a Climate Emergency, has pledged to make the District of Craven carbon neutral by 2030 and has produced a Climate Emergency Strategic Plan 2020-2030, which sets out specific actions to address the emergency.

Craven District Council has also adopted the Craven Local Plan 2012-2032. A local plan forms a major part of the statutory development plan for an area and planning law requires that applications for planning permission be determined in accordance with the development plan, unless material considerations indicate otherwise. Therefore, policies contained in the Craven Local Plan will be the primary consideration in the determination of all planning applications submitted to the Council. There are 45 policies in total, with supporting text, and they set out many requirements for all types of development.

The following table provides an assessment of how policies contained in the Craven Local Plan support relevant actions set out in the Climate Emergency Strategic Plan. Information and guidance provided in the table should enable the Council to use the Craven Local Plan to its optimum effect in addressing the climate emergency and fulfilling its carbon-neutral pledge. Policies are highlighted according to relevant themes of the Climate Emergency Strategic Plan:

Yellow for Carbon Neutral Development

Grey for Travel and Transportation

Green for Land and Nature

Blue for Carbon Neutral Energy or Low Carbon Waste

# **APPENDIX C**

# How policies of the Craven Local Plan could influence actions of the Climate Emergency Strategic Plan

#### Theme: Use of Materials

All current actions under this theme (UOM01 – UOM03) relate to ending or reducing the use of plastics by CDC and retailers and across the District. However, Local Plan policy ENV3 requires the use of locally sourced (building) materials wherever possible.

Suggest a new action: UOM04 Locally Sourced Materials – Reduce transportation miles and therefore CO2 emissions by requiring the use of locally sourced building materials in new developments, including Council projects, wherever possible.

#### Theme: Land and Nature

Most existing actions under this theme are supported by Local Plan policies. However, Local Plan policies ENV7, ENV10 and ENV13 also support the reuse of brownfield land and the preservation of greenfield land, which can contribute to reducing net carbon emissions.

Suggest a new action: LAN08 Conserve Greenfield Land – Minimise the urbanisation of greenfield land, which acts as a carbon sink and reduces net CO2 emissions, by encouraging the reuse of brownfield land for new developments, including Council projects, and by preserving areas of natural, semi-natural and cultivated land, including Council land.

#### Theme: Land and Nature

Existing action LAN01 is to increase tree Cover across Craven, including through large-scale tree planting by the Environment Agency and Woodland Trust. This action is already supported by several Local Plan policies, but policy ENV6 also supports Natural Flood Management and, therefore, carbon sequestration in soils, trees and other vegetation.

Suggest existing action LAN01 is expanded to promote NFM and the creation or enhancement of carbon sinks in soils and other vegetation.
