Report of the Democratic Services and Scrutiny Manager

Ward(s) affected: All

1. Purpose of Report

1.1 To consider appointing Honorary Aldermen and Alderwomen in accordance with Section 249(5) of the Local Government Act 1972.

2. Recommendations

- 2.1 To consider appointing Honorary Aldermen and Alderwomen in the final year of Craven District Council.
- 2.2 That the Appointment of Honorary Titles Committee presents its recommendations to an Extraordinary Council meeting convened specifically for that purpose.

3. Background

- 3.1 Craven District Council (CDC) has the power to grant the office of Honorary Alderman or Honorary Alderwoman to those it is felt have "rendered eminent services to the Council as past members of that Council" (s249, Local Government Act 1972).
- 3.2 On 1 December 2015, Full Council approved to increase the eligible period of former service as a Craven District Councillor as a qualification for appointment as an Honorary Alderman or Alderwoman from 15 to 20 years, which need not be continuous.

4. Report

- 4.1 On 31 March 2023, a total of 8 currently serving Councillors will have served at least 20 years. A further 4 currently serving Councillors will have served at least 15 years (see attached appendix).
- 4.2 Consultation with the other North Yorkshire authorities concludes that the eligibility period to qualify for appointment as an Honorary Alderman or Alderwoman ranges from 15 to 20 years. Some authorities specify that they also have to demonstrate "eminent service", though there is no official definition of what this constitutes as. One authority has chosen the alternative

- phrase of "a significant contribution to the Council and the people it represents".
- 4.3 In addition to those Councillors who have 20 years of service, the Committee may wish to consider Councillors who have not yet served 20 years, but who, in their views, have provided "eminent services" to the Council and to the people of the Craven District.
- 4.4 As North Yorkshire Council is a continuing authority, Councillors who are currently members of both CDC and NYCC ("dual-hatted" members) will continue as North Yorkshire Council members from the 1 April 2023 and their length of service will be carried forward. This means that for the purpose of the Local Government Act 1972, they are not <u>past</u> members, as their time in office will continue uninterrupted, and therefore they would not normally be eligible for Honorary Alderman or Alderwoman.
- 4.5 There is a consensus that qualifying district and borough members, who are also serving members of NYCC can be made honorary Aldermen or Alderwomen by their district or borough council. Whilst serving on North Yorkshire Council, use of this title will be suspended.
- 4.6 Once these members stop serving on North Yorkshire Council, and if they meet the eligibility criteria, they will receive the title of Honorary Alderman or Alderwoman from the new unitary authority. We have been informed that whilst North Yorkshire Council will honour Alderman and Alderwomen, it is unlikely that they will be marking the occasions with official ceremonies.
- 4.7 Craven District Council has previously appointed Beth Graham and Marcia Turner as Honorary Alderwomen and Kenneth Hart as Honorary Alderman.
- 5. Financial and Value for Money Implications
- 5.1 There will be expenditure in providing a scroll to those awarded the honorary title and placing names on the Roll of Honorary Aldermen/Alderwomen. This can be met within the Member Services budget.
- 6. Legal Implications
- 6.1 Powers to grant the office of Honorary Alderman or Honorary Alderwoman to who it is felt have "rendered eminent services to the Council as past members of that Council" (s249, Local Government Act 1972).
