

# LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

## The Craven District Council (Reorganisation of Community Governance) Order 2011

*Made* 23<sup>rd</sup> December 2011

*Coming into force in accordance with article 1(2)*

Craven District Council (“the council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made decisions through the Audit and Governance Committee at a meeting held on 21<sup>st</sup> March 2011.

The council has decided to give effect to those decisions and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by sections 86 and 240(10) of the 2007 Act.

### **Citation and commencement**

1.— (1) This Order may be cited as The Craven District Council (Reorganisation of Community Governance) Order 2011.

(2) Subject to paragraphs (3) and (4) below, this Order comes into force on 1<sup>st</sup> April 2012 or such other date as is set out in Schedules 1, 2, 3 and 4, whichever is the latter.

(3) For the purposes of:

- (a) this article, and
- (b) proceedings preliminary or relating to the elections of parish councillors for the parishes set out in Schedules 1, 2, 3 and 4 whose boundaries are to be changed on 1<sup>st</sup> April 2012,

this Order shall come into force on the day after that on which it is made.

(4) For the purposes of proceedings preliminary or relating to the elections of parish councillors for the parishes set out in Schedules 1, 2, 3 and 4 whose boundaries are to be changed on 1<sup>st</sup> April 2013, 1<sup>st</sup> April 2014 and 1<sup>st</sup> April 2015, the Order shall come into force on 15<sup>th</sup> October of the year preceding the changes, or such other date as is the qualifying date for the registration of electors that year.

### **Interpretation**

2.— In this Order—

“district” means the district of Craven shown on appended plan entitled ‘Parishes for the area of Craven District council’

“existing” means existing on the date this Order is made;

“plan(s)” means the plan or plans referred to in the Craven District Council (Reorganisation of Community Governance) Order 2011 and deposited in accordance with section 96(4) of the 2007 Act:

and any reference to a numbered sheet is a reference to the detailed plan appended to the Order which bears that number;

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983; and

“registration officer” means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

### **Effect of Order**

3.— This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

### **Grouping of parishes under a common parish council**

4.— The proposals to create a grouped parish council for each of the groups of Parishes listed below shall not be pursued:

- (a) The Parishes of Barden, Bolton Abbey and Hazlewood-with-Storiths; and
- (b) The Parishes of Airton, Calton, Otterburn and Scosthrop

### **Amalgamation of existing parishes and constitution of new parishes**

5.— (1) The existing parishes with the Proposal numbers shown in column (A) of Schedule 1 shall be amalgamated to constitute the new parishes shown in column (B) of that Schedule, each comprising the areas outlined in green on the plans appended to this Order.

(2) The new parishes shall be known by the name shown in column (B) of Schedule 1 and shall come into being with effect from the date shown in column (C).

(3) In consequence of paragraph (1), the existing parishes shown in column (A) of Schedule 1 shall cease to exist with effect from the date shown in column (C).

(4) The proposals to create new parishes from the amalgamation of each of the groups of Parishes listed below shall not be pursued:

- (a) The Parishes of Burnsall and Thorpe;
- (b) The Parishes of Halton Gill and Litton;
- (c) The Parishes of Airton and Otterburn; and
- (d) The Parishes of Barden and Bolton Abbey.

### **Arrangements for the new parish of Hellifield**

6. (1) The election of parish councillors for the new Parish of Hellifield shown in column B of Schedule 1 shall be held on the ordinary day of election of councillors in the year 2014.

(2) The number of councillors to be elected for the new parish of Hellifield shall be seven.

(3) The first annual meeting of the new parish of Hellifield shall be convened by the Clerk of the Hellifield Parish Council as at 31<sup>st</sup> March 2014 and shall be held by no later than 1<sup>st</sup> June 2014.

(4) The first annual meeting of the new Hellifield Parish Council shall be convened by the Clerk of the Hellifield Parish Council as at 31<sup>st</sup> March 2014. The meeting shall take place no later than 14 days after the day on which the councillors elected to the new parish council take office.

### **Annual meeting of Hetton-cum-Bordley Parish Meeting**

7. The first annual meeting of the new Hetton-cum-Bordley Parish Meeting shall be convened by the chairman of the Hetton Parish Meeting as at 31<sup>st</sup> March 2012. The meeting shall be held by no later than 1<sup>st</sup> June 2012.

## Wards of parishes

8. Parish wards for the Parishes of Bentham, Glusburn and Cross Hills, and Sutton-in-Craven will be as follows:

(1) Bentham parish–

(a) The existing wards for the parish of Bentham shall be abolished.

(b) The parish shall be divided into two wards which shall be named the High Bentham Parish Ward and the Low Bentham Parish Ward.

(c) Each parish ward shall comprise the areas described in (i), (ii), (iii) and (iv) below and designated on the plans appended to this Order by reference to the names of the Wards and Proposal 2.1 / 2.2.

New Boundaries for Bentham Parish wards –

(i) Area to the north of the Railway – This starts in the north of the Bentham parish, at the point where the Bentham / Ingleton boundary meets on the Bentham Road (unclassified), just to the east of Fourlands, from Ingleton to the west. Where the existing parish boundary with Ingleton, from a north-easterly direction, turns to the east, take the new parish ward boundary in a south-south-westerly and westerly direction to the point where the road meets the entrance to Fourlands. At that point, follow the road in a southerly direction, continuing south across the junction with Dumb Toms Lane. At the point where the road begins to turn to the south-south-east, take the field boundary to the south-west and follow it until it meets the Ellergill Beck. Continue the line along the centre of the Beck in a south-westerly / southerly direction until the Beck meets Fushetts Lane. Here, the boundary line turns south and follows the eastern edge of Fushetts Lane to its junction with the B6480 Low Bentham Road. Cross to the southern edge of the B6480 and then head in a westerly direction along the road to the point where the track to Cample Hatcheries meets the B6480 and head along the eastern edge of that track in a southerly direction. Follow the track in a southerly direction to its end and then take the field boundary that runs to the south and follow it in a southerly direction to the next field boundary just south of the Spring marked on the OS map. At that point, take the field boundary that goes in a west-south-westerly direction and then in a southerly direction until that boundary meets the Skipton to Lancaster railway line. Take the Parish Ward boundary due south across the railway line to the middle of the River Wenning.

(ii) Area to the south of the Railway – The new boundary will follow the middle of the River Wenning in a westerly and then southerly direction to a point just south-south-west of the waterfall, where the boundary exits the River on the south bank, opposite the waterfalls, along the watercourse that flows into the River Wenning at this point. Follow the centre of the watercourse for a short distance and exit to the east along the field boundary that runs alongside a path in a generally south-easterly direction. Where the path turns to the south-south-west, towards New Close Barn to the south, continue along the field boundary in an easterly, then south-easterly direction along the western edge of the area known as Crookbank Wood. At the south-western point of Crookbank Wood, immediately to the south of the area marked ‘Spring’ on the OS, take the field boundary that heads in a southerly direction for the length of the field to the east of that boundary. At that point take the field boundary that goes in an easterly direction until it meets another field boundary to the south-south-east around a wooded area. Follow that field boundary south-south-easterly around the wooded area and, where it meets the next field boundary to the east, follow that field boundary in a southerly direction for the length of the field to the east. Then head in a generally easterly direction along the field boundary that finishes at Moulterbeck Wood to the east and follow the boundary to the south around the Wood, to the point where it meets Moulter Beck. From this point, follow the centre line of Moulter Beck in a south-south-easterly direction until it meets the boundary to the south-west of the property known as Hazelwood. At that point, turn south-south-west along the boundary of Hazelwood and then south-south-east. Continue in a mainly southerly and easterly direction around the boundary of the property to the south-south-west of Hazelwood until that boundary meets the Moulter Beck again. Follow the centre line of Moulter Beck in an easterly and southerly direction through Smithy Wood and, as the Beck exits Smithy Wood to the south, take the south-westerly watercourse of Moulter Beck and follow it in a westerly and southerly direction until it crosses underneath Mewith Lane / West Lane Hill.

(iii) Area around Mewith Lane / West Lane Hill – Follow the line of the Beck to the southern edge of Mewith Lane / West Lane Hill and then turn in an easterly direction and follow that road until

its junction with the track to Flannagill. Follow the eastern edge of that track in a south-south-westerly direction to the point where the track crosses over Flannagill Beck. Then follow that Beck in a south-south-easterly direction through three small fields. In the third field from where the Beck goes under the track, a path crosses that field in a generally east-west direction. Take that path in a north-westerly direction to meet the southern boundary of the property know as Flannagill. Then turn to follow the path in a south-south-easterly direction for the length of that field to the point where it meets the unclassified road to the south. Follow the southern edge of the unclassified road in a south-westerly and then westerly direction until it meets the first field boundary to the south. Follow that field boundary in a southerly direction until it meets the District / Parish boundary.

(iv) In the parish of Bentham, all the land and property to the east of the new boundary shall comprise the High Bentham Parish Ward and all the land and property to the west of the boundary shall comprise the Low Bentham Parish Ward.

(d) The number of councillors to be elected for each of the Bentham parish wards shall be eight for the High Bentham Parish Ward and three for the Low Bentham Parish Ward.

(2) Glusburn and Cross Hills parish – Parish wards shall not be created for the two main settlements in the Glusburn and Cross Hills Parish.

(3) Sutton-in-Craven parish–

(a) The existing Sutton Ward and Sutton Mill Ward for the Parish of Sutton-in-Craven shall be abolished with effect from the next ordinary day of election for that Parish.

(b) The number of parish councillors for the whole of the Parish of Sutton-in-Craven shall be as shown in column (C) of Schedule 2.

### **Numbers of parish councillors for parish councils**

**9.** (1) The numbers of parish councillors to be elected for each of the parishes listed in column (A) of Schedule 2 will be the numbers shown in column (C) of that Schedule in place of the existing number shown in column (B).

(2) The effective date of election of the numbers of parish councillors shown in column (C) of Schedule 2 for the parishes listed in column (A) shall be the ordinary day of election for the year shown in column (D).

### **Alteration of parish areas**

**10.** (1) Schedule 3 contains details of alterations being made to areas of parishes and, in some cases, areas of parish wards.

(2) The reference and proposal number (in bold) for each alteration is specified in Column (A) of Schedule 3, along with the names of the parishes concerned. The reference and proposal number, together with the areas being moved from one parish to another and coloured yellow, blue, orange or purple are delineated on the relevant plans appended to this Order.

(3) Each of the areas referenced in column (A) of Schedule 3 and coloured yellow, blue, orange or purple shall cease to be part of the parish shown in column (B), and where relevant the parish ward shown in column (C), and shall become part of the parish specified in Column (D), and where relevant the parish ward shown in column (E).

(4) The alterations to the areas of the parishes referred to in columns (B) and (D) of Schedule 2 shall be effective from 1<sup>st</sup> April of the year shown in column (F).

### **Electoral register**

**11.** The registration officer for the District of Craven shall make such re-arrangement of, or adaptation to, the register of local government electors for the district as may be necessary for the purposes of, and as a consequence of, this Order.

### **Transfer of property, rights and liabilities**

**12.** (1) All the land and property delineated on the relevant plans referred to in Article 10(2) above and Schedule 3 shall become part of the parish specified in column (D) of that Schedule.

(2) All the domestic properties that have been identified and are to be transferred to another parish are shown in Schedule 4. Column (A) of that Schedule shows the parish in which the domestic properties specified are currently located and column (B) shows the parish to which they will be transferred.

(3) The alterations to the areas of the parishes referred to in columns (A) and (B) of Schedule 4 shall become effective from 1<sup>st</sup> April of the year shown in column (C).

### **Transitional provision**

**13.** Until the councillors elected to the council of the new parish of Hellifield at the elections to be held on the ordinary day of election of councillors in 2014 come into office, the new parish shall be represented by those persons who immediately before 1st April 2014 are the elected councillors for the former Parish of Hellifield.

### **Order date**

**14.** 1st April 2012 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

<p><u>Description of land as shown on plan marked “App1” and “Heb1”</u> – Amend boundary line from the point where the boundaries of the Appletreewick, Hartlington and Hebden Parishes meet at the most northerly most point of the Reservoir. From here, which is marked ‘Shingle’ on the Ordnance Survey plan (OS), follow the blue line indicating the westerly edge of the Reservoir on the OS map in a southerly and westerly direction, crossing Blea Beck east to west, at the point where it enters the Reservoir. Continue in a mainly southerly direction along the side of Blea Gill Bogs, past the New Laithe area down towards The Mires area. Head in an east-south-easterly direction, still following the blue line on the OS indicating the edge of the Reservoir to the point on the dam wall where the new boundary meets the current boundary, in the area where the River Dibb exits the Reservoir. The land and property to the east of the new boundary is transferred to Appletreewick Parish from Hartlington and the area to the north and west of the new boundary is transferred to Hebden Parish from Hartlington Parish.</p>

From the point where the western boundary of the Austwick Parish meets the A65 road, the new boundary will follow the northern most boundary of that road in an easterly direction up until the junction where the A65 meets the line of the former A65 road that goes to Giggleswick, along Buckhaw Brow. At that junction where the A65 meets the Giggleswick road, the new boundary will go south-east from the A65 along the northern boundary of the Buckhaw Brow road to Giggleswick and will finish where that road meets the eastern boundary of the Lawkland Parish with Giggleswick. <u>Description of land as shown on plan “Cra1”</u> – Re-align the north-eastern parish boundary between Cracoe and Linton, which runs through Swinden Quarry. Start at the point where the northern part of the Cracoe / Linton boundary at the western periphery of Swinden Quarry, comes near to the ford, across the Eller Beck, shown on the Ordnance Survey map (OS). From there, follow the eastern edge of the track that comes from Ratts Laithe across Linton Moor from the point where it meets the current Cracoe / Linton boundary, in a northerly then westerly direction across the Eller Beck ford until it becomes the footpath across Linton Moor that connects to Linton Moor Lane. Follow the eastern edge of the footpath in a westerly direction and then the southern edge of the footpath in a north-easterly direction to the point where it becomes a track for a short distance before running into Linton Moor Lane by the sheepfolds shown on the OS. Continue north-easterly along the southern edge of Linton Moor Lane until it reaches the B6265 Skipton to Grassington road. Then turn south and follow the western edge of the B6265 in southerly direction, past the junction with the unclassified road to Linton village, continuing in a south to south-westerly direction until the new boundary meets the current Cracoe / Linton boundary at a point where it crosses the B6265 and follows a track to the south of that road and then runs into Crook Beck. The land and property to the south and west of the new boundary is transferred to Cracoe Parish from Linton Parish.

<u>Description of land as shown on plan “Dra1”</u> – At the point where the Draughton western and Skipton eastern boundaries meet, to the north of Ellenber Farm, where the watercourse known as Skibeden Beck crosses beneath the A65 road, take the new boundary in a westerly direction along the southern side of the A65. The new boundary will follow the northern boundary of the area fronting the farm buildings and then along the boundary of the two adjoining fields to the west, heading west towards Skipton. At the western end of the second of the two fields, take the new line south along the boundary of the field to the point where it meets the next field and then west along the boundary of that adjoining field. ## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order gives effect to the implementation of decisions made by Craven District Council following a Community Governance Review of the Parishes of the District. The decisions relate to:

- Article 4 for the grouping of parishes under a common parish council;
- Article 5 amalgamating existing parishes to create new parishes for the Hellifield / Nappa / Swinden and Hetton / Bordley;
- Article 6 covering arrangements for the new parish of Hellifield;
- Article 7 covering the first annual meeting of the new parish of Hetton-cum-Bordley Parish;
- Article 8 establishing the warding arrangements for parishes of Bentham, Glusburn and Cross Hills and Sutton-in-Craven;
- Article 9 specifying the numbers of parish councillors for the parishes of Bradleys Both, Carleton-in-Craven, Clapham-cum-Newby, Cowling, Embsay-with-Eastby, Farnhill, Glusburn and Cross Hills, Grassington, Ingleton, Langcliffe, and Sutton-in-Craven;
- Article 10 altering the areas of a number of existing parishes;
- Article 11 obliging the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements;
- Article 12 transferring property, rights and liabilities; and
- Article 13 covering transitional provisions.
