The Core strategy is the main Local Development Framework document, which will set out the key spatial policies and vision for the District up to 2021. All other LDF documents must be in conformity with the Core Strategy.

This is the last chance the public has to influence the content of the Core Strategy. The comments received in response to this consultation exercise will be used to further modify the Core Strategy into a final draft, which will be submitted to the Secretary of State for approval.

A Sustainability Appraisal has been carried out on the Core Strategy Preferred Option document, and this will also be published for public consultation alongside the Core Strategy.
