Local plan timetable update

The latest Local Plan of Action Update and Progress Report is now available to download from our Local Development Plan Timetable web-page.

Sustainability appraisal scoping report

A draft sustainability appraisal scoping report is now available to download on the right hand side of this page.

Preparation of the new Local Plan includes assessment and comparison of reasonable alternative planning strategies, planning policies and potential development sites. Sustainability Appraisal is undertaken to consider the likely significant effects of these alternatives on environmental, economic and social considerations that are relevant to Craven.

Scoping forms the first stage of the Sustainability Appraisal and establishes the background position relevant to the Craven Local Plan area. The Draft Scoping Report has been produced in order to shape a sustainability appraisal testing framework that reflects the distinct local sustainability context. The Council is seeking views on the content of the draft scoping report that includes an analysis of current social, economic and environmental conditions in the district (including forecast future trends) and proposed sustainability testing objectives. Consultation is being held from Friday 20th December 2013 until Friday 7th February 2014. Comments may be sent to the Planning Policy Team by email, at localplan@cravendc.gov.uk, or by post. Viability Study - Community Infrastructure Levy (CIL) and Affordable Housing

Craven District Council has commissioned Peter Brett Associates to provide specialist viability advice. The aim of their study is to provide area-wide development viability assessments to inform the Council's approach to affordable housing policy as part of its new Local Plan. This will enable us to demonstrate what levels of affordable housing provision are viable, and the scope in viability terms to introduce a Community Infrastructure Levy, taking all other policy requirements into account. The SHLAA is a list of sites which have been suggested to the Council by a wide range of organisations and individuals as having potential for housing development. The Council has gathered information on each of these sites to assess how likely it is that a site would be available and suitable for housing development and whether it would have a reasonable prospect of being developed within 5 years or if it is likely to take longer to develop.
