Report to Craven Select Committee 280617 - Inspector Geoff Crocker Craven District

Crime Overview

The figures below are from the beginning of the financial year. A change in the definition of what is recorded as a burglary will now effect the figures for the next couple of years as we will see an incorrect comparison appearing on our statistics.

The old definitions of Burglary Dwelling, Burglary Commercial and Burglary Other have been replaced by Burglary Residential and Burglary Business and Community.

- **Burglary - Residential**

The classification of **residential** burglary includes all buildings or parts of buildings that are within the boundary of, or form a part of, a dwelling and includes the dwelling itself, vacant dwellings, sheds, garages, outhouses, summer houses and any other structure that meets the definition of a building. It also includes other premises used for residential purposes such as houseboats, residential care homes and hostels.

- **Burglary – Business and Community**

The classification of **business and community** burglary includes all buildings or parts of buildings that are used solely and exclusively for business purposes or are otherwise entirely outside the classification of residential burglary such as a place of worship. Where an outbuilding is within the boundary of a dwelling, but not forming part of the dwelling building, such as a garage or workshop and is used solely for business purposes this should be recorded as burglary – business and community.

This will I predict lead to an increase in the perception through the statistics of Dwellings being burgled and the comparisons with previous years will show increases.

Our activity is broken up into

ASB 13.1%

ROAD 24.7%

PSW 42.3%

CRIME 19.9%

Arson and Criminal Damage reports are up by 7 offences on last year or 11.5% overall with 68 offences recorded against 61 last year and 70 2015/16. Most of this is damage to motor cars with Skipton and Crosshills areas being the highest. Parking issues in Middletown and on Regents have largely led to some rises. Local elected members are aware of the parking pressure in these areas and work is still ongoing to attempt to address the concerns both of the commuters and local residents.

We have had 1 Robbery – Car Jacking against none recorded for the same period for the last 3 years. 2 West Yorkshire males arrested and vehicle recovered.

Burglary Residential shows as 14 offences and 3 attempts with 8 being in the Crosshills area Aire Valley with Lothersdale 2, Sutton-in-Craven 1, Cowling 2 and West Craven 3.

If the old definition were applied to these there would be 8 Dwellings broken into and there were 32 last year and 22 in 2015/16.

Burglary Business and Community shows as 20 offences. It is a little more complicated to assess but there were 42 offences of Burglary Other last year and 28 for 2015/16.

Taken overall there were 60 offences of Burglary (Dwelling and Other) recorded last year at this time whereas this year the joint figure is 39. This allows me to conclude Burglary incidents are down.

Sexual Offences are up to 14 offences against 4 last year and 11 for 2015/16 and rapes are also up to 6 offences from 2 last year and 10 in 2015/16. Whilst these are not statistically significant there are a significant number of girls represented who are 18 and under.

We are working with the Childrens Safeguarding Board on the theme for this year which is E-Safety and I hope members will support this work and encourage partners to become involved.

Theft – down by 14 offences to 41 against 55 last year and 52 for 15/16

Bike Thefts down 1 to 3 offence - 4 last year and 5 15/16

Shoplifting – up 5 to 32 from 27 and 52 in 15/16. It will be no surprise that Skipton has seen most of these although the Coop's in Crosshills still feature they are getting better and have introduced new working methods.

Theft From the Person – up 1 from 0 last year and 2 in 15/16

Vehicle Offences – up 15 to 41 offences from 26 last year but 53 in 15/16.

Stolen and aggravated vehicle taking – 6 offences down from 11 last year and 8 in 2015/16. A Landrover Defender stolen at the end of May initially by stealing the keys from a pocket in a hanging coat and returning a few days later to steal the vehicle. Landrover Defenders and quad bikes are still very popular with criminals.

Violence with Injury — up 3 offences to 46 from 43 last year and 44 in 15/16

Violence without Injury – Down 1 to 49 from 50 and 25 for 15/16 – we should see some stabilisation of figures this year as we have a second full year based on the new definition.

Drugs Possession down 11 offences to 11 against 18 and 13 for 15/16

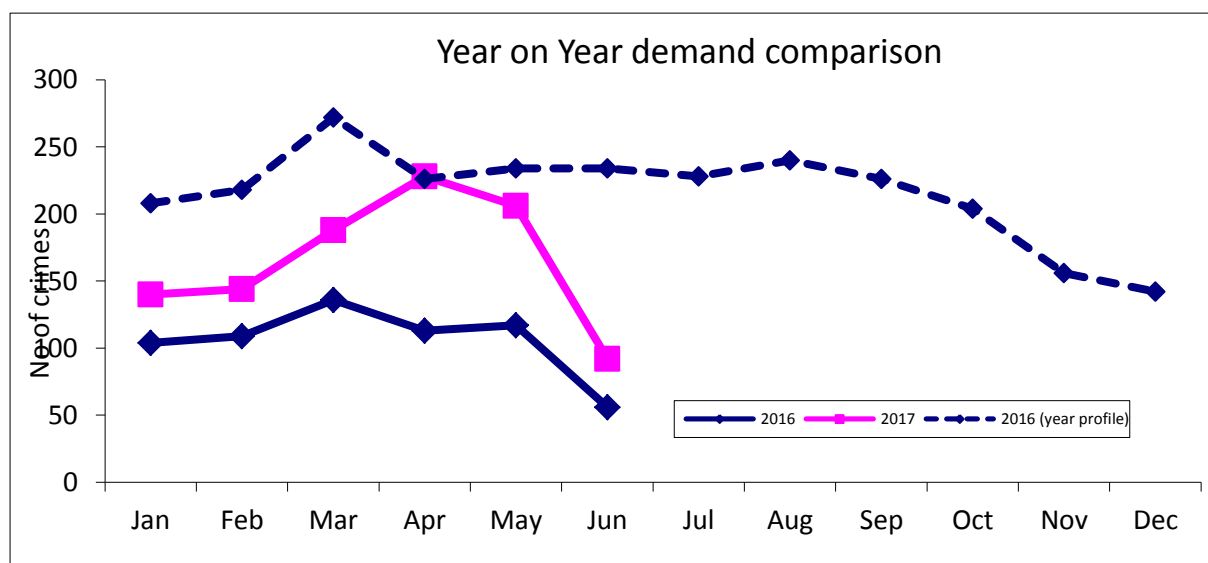
Trafficking Drugs – 1 offence down 2.

Possession offensive weapons – 1 offence no change

Public Order up 10 offences to 22 from 12 and only 7 for 15/16

In other news

1.

National crime figures have again confirmed North Yorkshire as the safest place in England.

This was announced on Thursday 27 April 2017 in the "Crime in England and Wales, year ending December 2016" bulletin, published by the Office of National Statistics (ONS).

There were a total of 36,680 crimes in North Yorkshire during this period, giving a crime rate of 45.3 per 1,000 of the population. While this reflects a 1% rise in crime in comparison to the same period the previous year, it is below the 10% increase in England and Wales and takes into account improved crime recording standards nationally.

Broken down into the main crime categories, the ONS figures for North Yorkshire show:

- Robbery reduced by 18% (137 crimes in total, 31 fewer crimes)
- Burglary reduced by 12% (3,642 crimes in total, 488 fewer crimes, of which 1,392 are recorded as domestic burglaries (a 5% decrease, 74 fewer crimes) and 2,250 non-domestic burglaries (a 16% decrease, 414 fewer crimes)
- Drug offences decreased by 17% (1,563 crimes in total, 318 fewer crimes)
- Violence against the person went up by 10% (9,468 crimes in total, 896 more crimes). This is broken down into Violence with Injury (4,635 crimes in total, 5% increase, 225 more crimes) and Violence without Injury category (4,827 crimes in total, 16% increase, 671 more crimes). This is largely attributable to the Violence without Injury category. This includes Common Assault and Harassment offences. Recent analysis confirmed this rise is linked to improved recording following a recent HMIC inspection, an increase in historical reports, increased proactivity around enforcement of orders and improved victim confidence
- Possession of weapons offences up by 16% (206 crimes in total, 28 more crimes)
- Theft offences down by 4% (16,211 crimes in total, 723 fewer crimes)
- Theft from person up by 2% (491 crimes in total, 9 more crimes)
- Bicycle theft increased by 8% (1,409 crimes in total, 101 more crimes)
- Shoplifting increased by 1% (4,065 crimes in total, 25 more crimes)
- Other theft offences down by 8% (4,354 crimes in total, 354 fewer crimes)
- Criminal damage and arson up by 2% (5,762 crimes in total, 121 more crimes)
- Vehicle Offences reduced by 1% (2,250 crimes in total, 16 fewer crimes)
- Sexual offences increased by 17% (1,340 crimes in total, 190 more crimes). As previously highlighted, this rise is regarded as a positive reflection of the confidence victims have in North Yorkshire Police, particularly those making historical complaints in the wake of high profile historical sexual abuse cases, plus support from dedicated facilities for victims of sexual assault
- Public order offences up by 7% (4,065 crimes in total, 91 more crimes)
- Miscellaneous crimes against society, which includes the possession and publication of extreme sexual images, increased by 17% with 635 crimes in total, 91 more crimes.

Deputy Chief Constable Lisa Winward said: “The fact that North Yorkshire has again been rated as the safest and lowest-crime area in England is something that everyone connected to North Yorkshire Police can take great pride in.

“It also reflects the outstanding partnership working that exists throughout the county and in the City of York, as well as the vital support provided by our local communities who rightly demand a very high level of service in return.

2.

Our second Camera Van has arrived. I have called for information on KSI and it would be an interesting study to observe what changes there are in these figures over the next 12 months. I hope we will see a reduction in KSI and a change in the % time spent on road related issues.

3.

DCC Lisa Winward announced on 8 March 2017, International Women’s Day, that North Yorkshire Police had made the decision to include misogyny into its hate crime policy from

10 May 2017. Misogyny hate crime is defined as: “**Incidents against women and girls that are motivated by the attitude of men towards them and includes behaviour targeted at them by men simply because they are women and/or girls.**”

4.

Police and Crime Plan 2017-21:

- **Caring about the Vulnerable:** We will have an in-depth understanding of how we can best protect the most vulnerable people in our society and will invest in services, skills and partner relationships to deliver the best possible outcomes.
- **Ambitious Collaboration:** We will reach out to partners and drive innovation forward to enhance policing, public protection, community safety and local justice services.
- **Reinforcing Local Policing:** We will equip our people with the technology, skills, capacity and personal support to prevent and tackle crime and reduce demand.
- **Enhancing the Customer Experience:** We will embed an outward-facing perspective to guide all our endeavours, providing an exemplary service that exceeds expectations, whether that be in serving the public, shaping the organisation or working with colleagues and partners.

Staffing – We are still actively recruiting and replacing those PCSOs who have now joined us as Constables. We have 2 PCSOs who start on the streets on 20th June and this will leave only 3 gaps to fill. 2 posts are actually staffing increases which I intend to put at Grassington and Crosshills. We have a Neighbourhood Constable vacancy in Settle which has just been filled by PC McClurg. Response shifts are all fully staffed which is great news. There are some Sergeant retirements this year and across the force Sergeant posts are being closely monitored. I anticipate we will see a promotion board in late autumn which may cause some movement as we have several constables capable of being successful in that process.

NYP through the Childrens Safeguarding Board has joined with Partners to enhance the Multi Agency Screening Team. The link here will give you more information.

MAST was created in September 2014, with the aim to consistently respond to child safeguarding contacts using Signs of Safety (SOS) Model, applying consistent thresholds across NYCC.

MAST have since expanded to 14 members of staff from CFS (social workers, social work managers, TLCW and APM prevention, North Yorkshire Police, HDFT, business support).

Stop Searches

Using the 2011 census data the Black or Minority Ethnic - Self Defined Ethnicity population in Craven is 4.4% of 55.500pop. Cravens search figures are consistently around 12% BME SDE.

We looked in detail at all stop searches from June 2016 to June 2017. Of the 143 records 22 were BME SDE and of these 20 identified themselves as Asian.

No patterns emerged regarding specific officers or targeting of individuals. Of the 22 these were 8 persons who self-defined as BME lived in Skipton, 12 had West Yorkshire addresses and the remaining 2 were from elsewhere. This is not unsurprising as the Craven area experiences a high degree of travellers / visitors whether these are criminals or persons traveling for leisure or work.

From the 22, 3 arrests emanated from the searches, 11 had previous convictions and the majority of searches were drugs related. Records were on the whole accurately completed.

The Stop-Search 'oversight' group has agreed to meet on Tuesday 27th June at 1700 at Skipton Police Station. County and District Councillor Andy Solloway has agreed to chair this meeting and Tahir Hussain, Secretary of the Skipton Masjid and Thabani Songo, resident and mental health manager have also confirmed attendance. This meeting has been organised with a view to offer more detailed independent scrutiny of the data.

This group could be constituted under the auspices of the Crime and Disorder Select Committee.

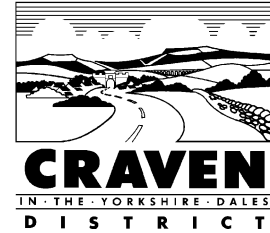

3. **North Yorkshire Community Safety Partnership (NYCSP)**

The NYCSP last met on 20th June 2017 and the key messages were:

- A health representative has now been identified to sit on the county CSP group
- The case management system (looked at by the CS JCG) which will identify commonalities of ASB etc from each district, and will act as a performance framework, will not be ready until sometime in 2018.
- The Prevent strategic board have a peer review in Sept. a key question to the board will be around governance and we are looking for recommendations for improvement. This is the largest geographical peer review ever undertaken by the Home Office.
- Events throughout the county are being organised in each district around Notice, Check, Share as part of the Prevent duty and will also include presentation on the role of the community safety hub. 2 events in Craven are being planned for October.
- A victims of terrorism unit (VTU) has been established, it will co-ordinate nationally to support citizens affected by recent attacks and any future attacks affecting British citizens at home or overseas. Two gov.uk web pages have been set up that contain advice on the support services available:

BRIEFING PAPER – CRAVEN COMMUNITY SAFETY HUB UPDATE**Multi-Agency Problem Solving Group meetings (MAPS)**

The monthly meetings continue to take place and include the local police commander (who chairs the meetings), various housing associations, social and mental health services, Fire Service, and District and County Council officers. Much of the focus of these meetings are various forms of anti-social behaviour causing a nuisance to residents although issues arising from the implementation of the PREVENT strategy and Hate Crime are also discussed as part of standing agenda items.

Currently there are 3 individuals who have signed anti-social behaviour contracts (ABC's), with a further 2 under consideration, and whose behaviour is being monitored.

In addition, referrals to the Mediation and Anger Management service – currently funded by the PCC - are considered.

There is one individual where a Civil Injunction application is pending.

Integrated Hubs

Community Safety Hubs have been established in each district now and in Craven the day to day work replaces that of the Local Delivery Team. The Hub is operational and ensures that multiple agencies and related organisations work effectively in partnership to make the communities within the district safer.

Craven's Community Safety Hub is managed by one full time Community Safety Officer (CDC) and a Police Officer. Housed predominantly within the council's offices it allows regular contact with Adult and Children's social services.

This arrangement is working very well with close co-operation on cases of anti-social behaviour. The Council's Community Safety Officer also attends the weekly police tactical meeting, where local issues and cases are discussed. There is also provision of a desk available at this location for the CSO.

Currently we have:

23 live cases

10 closed cases

0 high VRA's (vulnerable risk assessment)

6 Medium VRA's

1 pending civil injunction

1 PSPO (public spaces protection order)

1 PSPO pending to be reviewed Sept/Oct 2017

Anti-Social Behaviour, Crime and Policing Act 2014

A range of measures is available to the Council under the above legislation. The Public Spaces Protection Order which was implemented in October 2016 at Coach

Street Car Park will be reviewed in October 2017. A second proposed order for the town hall car park is to be reviewed again in the autumn to enable further consultation .

The Council's Cleaner Neighbourhood team (part of the Environmental Health service) deals with a large number of issues which originate in anti-social behaviour. The community safety officer is working alongside environmental health officers with issues around low level noise nuisance and assisting with an application by NYP for a civil injunction. This closer working partnership is working well for both depts within the council offering more resources to tackle cross cutting themes.

PREVENT Agenda

Local authorities have a statutory duty under the Government's PREVENT Strategy to have due regard to the need to prevent vulnerable people from being drawn into terrorism.

In North Yorkshire there are Local Prevent Groups (Bronze) in each district (including Craven), which report to the Prevent Strategic Board at county level (which is chaired by Paul Shevlin), as well as contribute to the development of the York and North Yorkshire Counter-Terrorism Local Plan (CTLP). Officers continue to identify local issues for inclusion in the next version of the CTLP.

In the autumn Craven plans to host 2 events highlighting the role we all play in helping people from becoming radicalised and drawn into terrorism. The first will focus on the Notice, Check, Share which supports trains and advises people where to go if they have anything to report. It will also promote the role and function of the community safety hubs. The second event will run alongside any events already planned, focusing on understanding what our communities look like and any emerging issues. It will improve community cohesion and provide awareness raising and reassurance in relation to the Prevent agenda. It is hoped that it will also improve community intelligence and assist in better information of future CTLP's.

In the wake of recent events the community safety officer will be holding basic awareness training (June/July) for CDC business support and reception staff around the National Police Chiefs Council RUN, HIDE, TELL advice, it outlines what to do if you find yourself in the rare event of a firearms or weapons attack. A run, hide, tell leaflet will also appear in the next round of staff payslips.

Saltmine Trust 'Stand for it?'

The theatre production/workshop aimed at young people (13-14yrs), which sensitively explores radicalisation and extremism was rolled out across the county and all schools within Craven with the exception of one who hosted the production. There is now a DVD which has been produced of the same production to be given to each of the schools to enable them to host showings at their leisure.

Funding

Applied for during the 2016-17 financial year there is still currently approx £1900 specifically to be used for target hardening projects. This funding has been extended to be spent by Sept 2017. We are focusing on a scheme that supports victims of burglary and a rise in fire related domestic abuse incidents.

Under the Community Safety Services Fund available through the OPCC, there is currently 55k specifically for any local organisations to bid in for help with any individuals that have complex mental health needs. We have encouraged our local mental health agencies to bid in for this funding.

COMMITTEE WORK PROGRAMME

(2) That if necessary the Select Committee scheduled for 26th July 2017 is replaced by a meeting of the Waste Management Working Group, and that a meeting of the Shared Ownership Working Group is convened on conclusion of the Select Crime and Disorder Committee on 28th June 2017 to enable it to review the position reached and whether any further information is required before it concludes its review.

(3) That the following matters are scheduled for consideration as indicated:-

- a. Select Committee 6th September 2017 : Sickness absence, vacancies monitoring and call handling performance.
- b. Select Crime and Disorder Committee 6th December 2017 : Review the effectiveness of any public spaces protection orders.

(4) That, pending further consideration as to whether the Council's arrangements when measured against the green travel plan for Belle Vue Square should be reviewed, copies of the Green Travel Plan are circulated to Members of this Committee.

(5) That the Member Ward Grants Scheme is retained within the work programme as a possible item for review, should a review be considered appropriate at some future point in 2018 or beyond.

(6) That partnerships are subjected to a light touch review during the course of 2017/18, and that as previously indicated a further review of the Garden Waste Subscription Service and the position on cost recovery is carried out within the period ending December 2018.
