Glusburn Institute	As Chair of the Trustees for Glusburn Institute, we have agreed to recycling containers on our land. We think these should be continued as a service to the local community, especially since nearby properties have very little outside space for their own bins. If you do not have a car then access to other recycling sites is extremely difficult. We have no reason to believe our site is being misused by local traders but we do think the modern trend for online shopping has led to a big increase in large cardboard boxes needing to be recycled. Again breaking these up is easy for someone who is physically able be difficult for more elderly residents	
Farnhill Parish Council	Farnhill Parish Council would like to respond to the consultation on Recycling Bring Sites by stressing that they feel the sites should be kept open. Kerbside Recycling is carried out once every two weeks for cardboard and once every 4 weeks for plastic & tins, but for some properties where space is limited struggle to find the space to keep the goods and take some to bring sites in between collections.  We feel that to close the sites would result in more fly tipping which results in more expense for the Council.	
Embsay with Eastby Parish Council	The Parish Council are in favour of retaining the village 'bring bins'. The recycling site at Embsay Main Street Car Park (not the Village Hall as listed on the CDC website) is well used by residents in the locality who do not have a blue bin - either by choice or more importantly beacue there is insufficient space fopr storage of the bin within the curtilage of the property. The Parish Council would therefore request that the site remains in situ.	
Bentham Parish Council	As the associated questionnaire appears to be designed for individual use, asking specific questions about the use of kerbside / bring site recycling, the Council asked me to respond to you directly. The Council acknowledges that the recycling of cardboard, possibly commercial, is costing Craven a significant sum, but feels that the Bring Sites are still popular. It can only comment directly on those in High & Low Bentham, but these sites are well used most often by those who live in properties that do not have space for recycling bins. It noted that the NSPCC monthly paper collection in Bentham will soon cease due to funding changes, which may lead to greater usage of the local Bring Sites as another recycling alternative will be lost. The Council would actively encourage Craven to maintain these sites as it believes that their removal will almost certainly increase fly tipping around the District which will add significant cost to the District Council in dealing with the problem.	
Grassington Parish Council	Grassington had a prominent recycling site on the YDNP car park which was encouraging fly-tipping and excessive amounts of commercial cardboard. YDNPA removed this facility last year which transferred the problem to the site operated by CDC adjacent to the Town Hall. Accordingly Craven DC have, in response to a request from Grassington PC removed their "bring site" from Grassington. We do not wish to have such a facility in our village	

Parkfoot Holiday & Park Homes, Ingleton	We pride ourselves in having a sustainable tourism business which includes encouraging our customers to recycle as much as possible. In addition to the bins for paper, cardboard, glass, and tin in the 'bring site' at Parkfoot, we collect batteries, stamps, books, videos, dvds, mobile phones, ink cartridges for recycling. We have specially designed signs on the 'bring site' gates requesting customers recycle tetrapaks and plastics at the 'bring sites' in Ingleton and Settle. We have also purchased signs for the normal waste bins aimed at reminding customers to recycle wherever possible. So for the Council to consider reducing recycling facilities seems to me a very retrograde step. Several years ago I asked if a bin for plastics recycling could be added at Parkfoot as I am aware that our general waste contains many plastic bottles: not everyone is prepared to collect them and then drive several miles to recycle them or even take them home – they're on holiday! The idea was treated sympathetically but rejected. I am sure that someone within the Council is well aware how much waste is recycled in the Parkfoot 'bring site' unlike the general waste bins, the recycling bins are not being charged for by the Council. However, our general waste bins are rarely full, and with recycling facilities are unlikely to be so, but we have never reduced the volume paid for preferring to ensure that customers have a bin in a reasonable handy position for them to use. However if the recycling facilities are reduced here, and in Craven as a whole, I am certain that the general waste levels will rise significantly. Charging for the recycling bins would not produce the increased income that you'd expect as businesses would make strategic changes to ensure that, even if the recycling site was retained, the costs of waste processing did not significantly increase
