
2. <u>Purpose of the Council Plan</u>

- 2.1. The Council Plan sets out the Council's agenda for improving service delivery to Craven communities, and organisational change. The updated Plan covers the period to 1 April 2015 to 31 March 2018. The plan focuses on the Council's top priorities for improvement. It does not include everything the Council will do.
- 2.2. The Plan sets out the Council's vision and priorities for the next 3 years. It details the actions and projects to be delivered by the Council against its priorities in delivering and improving services.

3. <u>Council Plan Development</u>

- 3.1. The plan for 2015/2018 has been developed following a review of the current 2014/2018 Council Plan in consultation with CLT, Council Leadership Team, and Lead Members.
- 3.2. Specific consultation has not been undertaken on the Plan; however the 2015/2016 Budget Consultation included a question on the Council's current priorities. Consultees were asked 'Do you think these priorities are still the right ones for 2015/18?' Yes, No, Don't Know. The majority of respondents stated 'yes' that the current priorities of Enterprising Craven, Empowering Communities, Greener Craven and Financial Resilience were the right ones for 2015/2018 onwards. The detailed results of this question are shown below.
