COLLECTION FUND NATIONAL NON-DOMESTIC RATES SURPLUS/DEFICIT 2014/15



Report of Strategic Manager – Financial Services (s151 Officer)

Ward(s) affected: All

1. <u>Purpose of Report</u>

1.1 To declare the estimated National Non-Domestic Rates (NNDR) surplus / (deficit) on the Collection Fund for 2014/15.

2. <u>Recommendations</u>

2.1 Declare an estimated deficit of £2,400,175 on the Council's Collection Fund at 31st March 2015 relating to NNDR transactions.

3. Background Information

- 3.1 The Collection Fund records the amount of income collected from NNDR, together with payments on account to central Government, the County Council and Fire and Rescue Authorities and this Authority. The Council is required to declare an estimate of the surplus or deficit that is likely to occur on the Collection Fund at the end of each year in January of that year.
- 3.2 Under the rates retention scheme, which came into effect on 1 April 2013, local authorities are able to keep a proportion of the business rates that they collect. As a result, authorities now have a direct financial interest in the rates retention system and an incentive to work with their business community to grow local economies.
- 3.3 Any surplus or deficit relating to NNDR is shared between Central Government, the County Council, the Fire and Rescue Authority and this Council in prescribed proportions under the Non-Domestic Rating (Rates Retention) Regulations 2013.
- 3.4 Any surplus or deficit may occur in the Collection Fund if the amounts billed or collection rates are higher or lower than the estimate set at the start of the year on the NNDR1 return.

4. Estimated Deficit for 2014/15

- 4.1 The amount calculated as the deficit on the NNDR Collection Fund for 2014/15 is £2,400,175.
- 4.2 This amount has to be shared by the precepting authorities as follows:

•	North Yorkshire County Council	£216,016
•	Central Government	£1,200,087
٠	North Yorkshire Fire and Rescue Authority	£24,002
•	Craven District Council	£960,070.

- 4.3 This Council must take the £960,070 into account when it sets its element of the Council Tax for 2015/16.
- 4.4 It is not unusual for a variance to be estimated on a collection fund. The ideal situation is for it to break even year on year, but when dealing with figures in excess of £19m a surplus / (deficit) could occur.

5. <u>Implications</u>

5.1 **Financial and Value for Money Implications**

The Council has to take account of its proportion of the estimated surplus / (deficit) in setting the Council Tax for 2015/16

5.2 Legal implications

The calculation of the apportionment of the surplus or deficit is prescribed under the Non-Domestic Rating (Rates Retention) Regulations 2013.

5.3 Contribution to Council Priorities

The surplus/deficit may impact on the funds available for the Council in setting a balanced budget.

5.4 Risk Management

Failure to achieve a balanced budget in the financial year would have had serious consequences for the Council.

5.5 Equality Impact Assessment

The Council's Equality Impact Assessment Procedure **has been** followed.
