Welcome to our Annual Report

We had a challenging but exciting year in Craven in 2015-16 with a number of highlights standing out against a tough national climate.

With further reductions in Government grants we have been focused on managing budget cuts by finding significant savings and generating additional income.

Partnership working has also been crucial with our scheme to build a new skate park and pump track in Aireville Park an excellent example of this.

By working with Craven Youth Council and Friends of Aireville Park we were able to access funds which wouldn't otherwise have been available, in order to raise the £100,000 needed to build the two new facilities.

Our ambitious plans to transform Skipton Town Hall into an arts hub for the district also took a huge leap forward in 2015-16. This is another project which will provide great benefits for the whole of Craven while also providing a source of income for the Council.

Craven Museum and Art Gallery is also well on its way to a major transformation after we were awarded an initial grant of £98,000 from the Heritage Lottery Fund, which will pave the way to a further bid for £1.4 million over the next year. The museum showed its potential with the magnificent Faith in Art exhibition, which attracted visitors from around the country.

Settle Tourist Information Centre went from strength to strength with a prestigious TripAdvisor Certificate of Excellence, as plans began to host the Tour de Yorkshire Stage One finish, which took place in April 2016.

A £100,000 scheme to transform Cross Hills village centre into a vibrant location for residents and visitors got underway, while another £110,000 was invested in improvements to Ingleton village centre.

We helped hundreds of homes and businesses around the district connect to superfast broadband, including Clapham, Ingleton and Chapel-le-Dale via the Broadband for Rural North network. Our staff also worked hard to help those in need, from our own residents struggling to cope with flooding, to Syrian refugees fleeing the war in their country.

We face more difficult times ahead as the Government grant to local authorities is due to be cut to zero by 2020, but we will continue to do our best to serve and support our communities.

About us

Craven District Council represents 55,696 local residents across 450 square miles of beautiful Yorkshire Dales countryside, placing it in the top ten lowest population density councils in England.

Craven covers 15% of North Yorkshire, including the market towns of Bentham, Settle and Skipton, where the council offices are located.

The administrative area includes the southern part of the Yorkshire Dales National Park as well as the upper parts of Airedale, Wharfedale and Ribblesdale plus Wenning Valley near Bentham.

Craven has 30 elected Councillors across 19 wards, who are on hand to help if you want to discuss a local service or anything else that affects your community.

Councillors are elected by residents every four years. Their main decision-making body – the Policy Committee – makes most of the policy and strategic decisions. For certain major policy issues, the Policy Committee makes recommendations to the Council Meeting, where all members sit and vote.

The responsibility for all the Council's functions and services is vested in the Council Meeting, but many of its powers and duties are delegated to committees, sub-committees and officers. To find out more about the services that we provide, please see pages 17-21.



Our Council Priorities: How we measure up

The Council's vision is for Craven to be an increasingly prosperous place with strong, vibrant communities that celebrate their unique rural and urban settings, and where all residents enjoy a good quality of life.

To help us achieve this we set ourselves four priorities for 2015-2016

• Enterprising Craven • Working With Communities • Financial Resilience • Greener Craven

Enterprising Craven

Superconnected Craven Broadband Voucher Scheme

This scheme was launched in April 2015 and awarded 85 businesses with vouchers worth a total of £110,000 to access improved broadband connectivity. The Council exceeded its target of delivering support to 64 businesses, or 2% of the district's business stock through the scheme.

The scheme was funded as part of the Government's Superconnected Cities programme to increase the takeup of superfast broadband. Evaluation of the programme shows that each business receiving a voucher benefited from an additional $\pounds1,300$ profit per annum and created 0.27 jobs per business; equivalent to 23 jobs in Craven.

The Voucher Scheme helped to provide the support needed to enable the community of Clapham to realise its aspiration to receive hyperfast broadband by connecting to the Broadband for the Rural North (B4RN) network.

Hyperfast broadband

The year saw the formation of community-led projects in Ingleton and Chapel-le-Dale to build a connection to the Broadband for Rural North (B4RN) network. Both projects will deliver access to hyperfast broadband for some of the district's remoter communities. The Council has assisted both projects by giving permission to use its land to accommodate infrastructure, giving advice and support on project development and delivery, and the provision of a community grant.



Digital Enterprise Support Programme

In December, the Council agreed to make a contribution of £8,000 to support a bid for £4.2million of European funding to deliver a Digital Enterprise Support Programme across the Leeds City Region, including Craven. The programme, which is worth £8.4 million, will provide businesses with training, mentoring and access to capital grants to improve their digital infrastructure.

Leeds & Liverpool Canal Improvements

In July, the Council agreed to invest up to £300,000 of its New Homes Bonus receipts to improve accessibility along the stretch of the Leeds-Liverpool Canal running through Craven District. This is in addition to the £450,000 of funding secured last year from the Department of Transport to upgrade the 4km section of towpath from Skipton to Bradley, and which was completed by the Canal & River Trust in July 2016.

In November, the Council commissioned initial design ideas and feasibility work for the future replacement of Gallows Bridge in Skipton in order to improve the accessibility of this direct route between the town centre, bus station and railway station. Up to £10,000 has been made available from the Council's New Homes Bonus receipts to fund this work.

Skipton Flood Alleviation Scheme

The start of the town centre flood defence works which form part of the Skipton Flood Alleviation Scheme was launched in January.

Costing £13.8million, the scheme will reduce the risk of flooding to more than 500 homes and businesses in the town. The Council has worked closely with the Environment Agency to secure the funding needed. The Flood Alleviation Scheme will enable land, which is currently in the floodplain to be developed for employment. Weather permitting, the scheme should be completed by early 2017.

Wyvern Park, Skipton

Planning permission was issued for the development of phase one of Wyvern Park. Located on the edge of Skipton town centre, the development will provide 24,155 square metres of new employment space, accommodate up to 1,040 jobs and 200 houses. It is expected that the development will generate £30million gross value added annually for the Craven economy. The developer is looking to start work on-site in early 2017.

SME Growth Manager

In June, the SME (Small and Medium-sized Enterprises) Growth Manager started. The post, which is partfunded by the Leeds City Region Local Enterprise Partnership, is part of the region's business growth service. Launched in 2015, the service has been created to help those businesses that want to grow to explore and identify the support that is right for them.

During the first nine months, the SME Growth Manager has worked with 13 businesses from a mix of sectors such as manufacturing and engineering, distribution and logistics, and healthcare technologies. The type of support provided includes assistance in finding and securing finance, developing the skills of their workforce, exporting, to boosting productivity and reducing energy costs.

Evaluation carried out to assess the impact of the growth service in its first year, found that 71% of businesses said they were more likely to meet their growth aspirations as a result of the support they received from the SME Growth Manager.

Ad:Venture – Enterprise Support Programme

The Council joined a local authority-led consortium, to bid for $\pounds 0.88$ million of European funding to deliver a $\pounds 13.76$ million programme of wrap-round support for pre-start, young and new firms with growth potential in the Leeds City Region. In July, the Council agreed to make a contribution of $\pounds 46,123$ to support the costs of delivering the programme (known as Ad:Venture) in Craven.



Businesses Assisted

During the year, the Council assisted 108 businesses to improve their performance, either through the provision of consultancy at one of the Pop-Up Business Advice Cafes held in Ingleton and Skipton, or at one of the masterclasses focusing on topics such as successful retailing online and finding new ways to increase visitor spend. The number of businesses assisted exceeded the Council's target by 2.86%.

Tourist Information Centres

Skipton Tourist Information Centre, at Skipton Town Hall, saw 86,187 people come through its doors in 2015-16. The Centre reopened in a new location in the Town Hall in February 2016, and is now at the entrance to Craven Museum and Gallery, giving it more visibility to promote Skipton, Craven and the surrounding area.

Settle Tourist Information Centre provided assistance to 26,594 people, including a growing number of residents seeking clarification on changes to bus timetables, ideas for entertaining visiting friends and family, a supply of doggy poo bags and applying for bus passes and parking permits. The number of people helped exceeded the Council's target by 15.6%.

In June, the Centre was awarded a prestigious TripAdvisor Certificate of Excellence. The Centre was given the award after consistently achieving outstanding traveller reviews on the influential website. The majority of reviews gave the Centre a rating of excellent and many of the reviewers mentioned the friendly, knowledgeable and helpful staff.

Market Towns - Ingleton

In June, the Council agreed to invest £110,000 of its New Homes Bonus receipts to support the delivery of the Ingleton Village Centre Action Plan. Developed in partnership with Ingleton Parish Council and local businesses, the plan identifies a series of projects that have been designed to improve the attractiveness of the village centre environment and help businesses improve their productivity. The first of these projects was completed in March with the refurbishment of the main car park and introduction of a "Pop and Shop" scheme to give residents and shoppers access to low cost parking that is close to the main shopping area.

The refurbishment work included the creation of a new pedestrian walkway, resurfacing, new lighting and landscaping, including the removal of an old Portakabin to open up the view across the Viaduct.

Market Towns - Cross Hills

In July, the Council agreed to use £100,000 of its New Homes Bonus receipts to deliver a number of actions to improve the appearance of the core retail area. The first of these projects is the refurbishment of Hall Street car park to provide an events space, provision of new street furniture and creation of a seating area with flower beds.

Town Centre Health Checks

In February, a series of six town centre health checks were published. The health checks investigated representation of businesses, environmental quality, accessibility, customer views and behaviours within the market towns and service centres of Bentham, Cross Hills, Grassington, Ingleton, Settle and Skipton.

Common themes identified included higher than average representation from convenience retailers, low footfall and areas of public realm and street furniture in need of improvement and investment. The health checks also noted that each of the towns is positioned in a high quality environment with low levels of crime and a good range of quality independent retailers.

The health checks form part of the Craven Retail and Leisure Study commissioned to assess the current convenience and compare retail and leisure offer across the district and provide a robust evidence base to inform retail and town centre policy within a new Local Plan for the District.





Working With Communities

2015/16 was an exciting year for our communities with a range of events and developments taking place.

Pump Track and Skate Park

We were delighted to open a new pump track and skate park in Aireville Park in Skipton, thanks to a number of sponsors and partners, and Friends of Aireville Park. This is a fantastic new facility for young people in the district and has been extremely well used.

South Skipton Project

Our partnership support for the South Skipton project continued. The project won £8,400 from Awards for All, part of the Big Lottery Fund, for a Community Leadership Programme, while Scoff Café went from strength to strength and won a Community Champions Award.

Cycling Legacy

We continued to build on the legacy of the Tour de France with a number of cycling events as we established the district as a hub for the sport. Skipton Cycle Races, featuring fun races for children and an elite Criterium race around the town centre, was a thrilling event and was so successful that British Cycling included the town in its elite series for 2016. Le Petit Depart attracted hundreds of amateur cyclists to take on some of the Grand Depart route, and Settle was announced as a host town for the Tour de Yorkshire Stage One finish.

Community Champions

The Community Champions Awards continued to go from strength to strength in 2015, highlighting some incredibly dedicated people who put in huge amounts of time and effort to improve and enrich their communities.

Community Grants

During 2015/16, 25 groups were awarded community grants totalling £21,072. Projects to receive funding ranged from £150 to £2000. On average CDC grant funding made up 5.5% of the total costs for each project. This means that each £1 of grant funding awarded by Craven District Council was matched by £17 of funding from other sources, bringing in additional funding of £359,149 to support community projects in Craven.

Flooding Support

Our Environmental Health, Cleaner Neighbourhoods and Waste Management teams work hard all year round to provide crucial services to the communities of Craven. In the winter of 2015/16, we were called upon to help tackle some serious flooding in parts of the district, distributing thousands of sandbags during severe weather over the Christmas holidays. Our Environmental Health officers were working for long hours in terrible weather conditions, some dropping their Christmas plans at very short notice to turn out and help.

This demonstrated the Council's teamwork at its best – if it were not for the efforts of these dedicated officers, many more properties would have been affected by the floods. We also helped residents recover from flooding by assisting them to access grant funding.

Financial Resilience

The Council has continued to address the financial pressures it faces in the light of cuts to government funding to ensure it remains financially sustainable and has robust arrangements in place for securing value for money.

Financial Plan

The Plan sets a target of £1 million in additional income/savings by the end of 2019/20. £100,165 has been achieved in 2015/2016 against a target of £300,000, due to slippage in the timescales of a number of projects. Savings identified include insurance, banking and mobile phone contracts and agreements of leases at Skipton Town Hall. Work will continue to deliver a number of further projects in order to meet the savings needed to balance the Council's budget.

Shared ownership housing developments

A specific area of focus as part of the plan is building homes for shared ownership or rent, with expectations of generating £45,000 in additional income by the end of 2019/20. Approval has been given from members to acquire three properties from developers as part of a shared ownership scheme and planning permission for the development of three houses has been granted as part of a pilot scheme.

Exploring savings

Together with Selby District Council, the Council had been running a procurement exercise looking to find a partner for the delivery of the Revenue and Benefits Service, and in addition for IT services for the Council. Expectations included in the Council's Income and Savings Plan were for a £10,000 cost saving. The procurement process has however been terminated following detailed evaluation of outline submissions which did not sufficiently align with the Council's aspirations for the services. The Council will continue to explore options for improving the service and delivering value for money.

Skipton Town Hall

The Council has continued to implement its business plan to restore Skipton Town Hall as a sustainable and vibrant community venue, investing further capital expenditure of £395,000 for refurbishment and alteration works and £20,000 from the New Homes Bonus Infrastructure Reserve allocated for a feasibility study for the future development of the concert hall. The Plan includes developing the space for letting to a range of business and commercial entities. This has generated additional income in the region of £9,000 in 2015/16 and is expected to generate further income in the region of £268,000 to the end of 2019/20.

Greener Craven

Carbon emissions

We have committed to reducing carbon emissions both within Craven District Council and throughout the Craven district as a whole. This year, efficiency changes were made at the Crematorium to reduce carbon emissions and fossil fuel usage. Skipton Town Hall also reopened with a brand new boiler replacing the ancient, inefficient boiler, improving the energy efficiency of the building.

Green spaces

Craven communities were asked to identify important areas of green space which need protecting in the district. We asked people, via Town and Parish Councils, to put forward areas of green space for consideration for designation as Local Green Space in either the Craven Local Plan or in Neighbourhood Plans prepared by parishes.

Energy efficiency

The council continued to work with Better Homes Yorkshire to support residents to make their properties more energy efficient, and funds were made available to residents of the Leeds City Region, including Craven.

Recycling

Recycling levels across Craven were at 41.38 per cent. This year we also started collecting beverage cartons as part of the recycling collection. We also provide a garden waste subscription service; in 2015/16, a total of 8,709 properties across Craven had 9,065 garden waste licences.

Customer Services

Between the week commencing the 6th April, 2015 and the 28th March, 2016, Craven District Council dealt with 32,365 visitors in reception, which is a slight increase on the previous year.

Our call centre received 61,929 calls of which 53,733 were answered (86.8%). This was a substantial increase in calls received in 2014/15, so it is good to report such a high percentage of calls still being handled.

The Shakespeare First Folio on permanent display

The Shakespeare First Folio is thought of as the most important book in English literature containing the collected plays of the world's greatest playwright. Without it, 18 of Shakespeare's plays would not be known today including Macbeth and Romeo & Juliet. Skipton's First Folio is one of only four that are currently on permanent display in the world.

Planning

We dealt with a total of 1021 planning determinations in 2015-16 and exceeded national targets in all areas across the year.

Major Planning Applications include residential schemes for 10 or more dwellings, residential development on sites over 0.5 hectares, other development providing floorspace greater than 1000 m2, and other development on sites of over 1 hectares.

Minor Planning Applications include proposals for dwellings, offices, industry, retail development, and other built development, but excluding householder/other development and development which is classed as major.

Other Planning Applications include householder applications, changes of use, advertisements, and listed building consent applications.

Other determinations are applications that are not included in the Performance Indicators and include applications relating to tree matters and applications for non-material amendments.

Work continued on Craven's Draft Local Plan in preparation for a public consultation to run from April 5, 2016 to May 31, 2016, on the second informal (pre-publication) draft of the new local plan.

Revenues and benefits

Welfare Reform continued with further changes to Housing Benefit. The increased effect of the reforms saw a 64% increase (compared to the previous year) in expenditure from the Discretionary Housing Payments fund.

Craven also saw the arrival of Universal Credit although numbers claiming it remain relatively low. Universal Credit will continue to be rolled out this year and the number of people claiming it should dramatically increase from October 2016. The Council Tax Reduction Scheme remained unchanged in 2015/16.

Despite the welfare reforms it is pleasing to report that Council Tax collection remained constant and Craven remains in the upper quartile for collection performance.

Housing Options

The Housing Options Service provides the council's statutory services in relation to homelessness and housing advice. The number of households accessing the service has remained high with 322 approaching in 2015/16. There has been a substantial increase in the number of households approaching with issues relating to renting accommodation at 37% compared to 20% last year, and we anticipate this increasing over the next year due to new welfare reform initiatives.

The team have prevented 39 households from becoming homeless, which is an increase on the previous year. We have also issued 20 Bonds and Rent in Advance.





Craven Community Safety Partnership

The Craven Community Safety Partnership aims to support the reduction in crime across the district by working with and supporting various organisations including statutory authorities in the district (for example housing associations, social services, mental health services, and the police).

Priority areas include anti-social behaviour, domestic abuse, children and young people, and rural crime. Along with all local authorities, the Council also has a statutory duty to implement the Government's PREVENT strategy which aims to prevent vulnerable persons from being drawn into terrorism.

Every month a group of colleagues within the partnership meets to consider individual cases or issues where there may be a need for support or intervention working together, and preparatory work has been undertaken to implement the powers conferred on local councils by the Anti-Social Behaviour Crime and Policing Act 2014.

A number of training sessions to raise the awareness of the PREVENT duty have also been delivered in the district to councillors and officers.

The levels of reported crimes across the district continue to be low when compared with the county and national picture.



Bereavement Services

- Waltonwrays Cemetery and Crematorium Social History Display: Staff at the Crematorium have pulled together (with the help of Craven Museum staff) a social history of Waltonwrays cemetery and crematorium which dates back to its opening in 1873. There are many artefacts on display in the Book of Remembrance Chapel, including information relating to the design of the buildings, mourning jewellery and two biers (the carriages used to transport coffins from homes to the cemetery). Other interesting items include information regarding the setting up and opening of the crematorium in 1952, the official opening invitation and old photographs.
- Bronze Standard for Burial and Cremation Services: Craven Bereavement Services has become a member of the Charter for the Bereaved, and has achieved the Bronze Standard. The Charter for the Bereaved is managed by the Institute of Cemeteries and Crematorium Management (ICCM) in order to set standards of service for the industry. Members of the public can be assured that an authority that has adopted the Charter is committed to providing an excellent service designed to meet their needs.
- Bereavement Service improvements: Following consultation with funeral directors, ministers and the bereaved, there have been some changes to the service to improve them. These include the extension of chapel service times from 40 to 50 minutes to improve the customer experience. The holding over of coffins, with the applicant's consent, has been introduced to reduce carbon emissions and fossil fuel usage. Efficiency savings are also being made by emailing all cremation forms to the medical referee, following approval to do so by the Ministry of Justice.



Environmental Health

- We undertook 215 food safety inspections and investigated complaints about food and food premises.
- There was 1 outbreak of food borne disease in Craven last year, namely Cryptosporidium.
- 72 risk assessments were carried out on private water supplies which serve more than 22% of the population of Craven along with routine sampling. 47% of these samples contained unacceptable levels of bacteria.
- We supported all the larger festivals held in Craven this year.
- 53 private sector housing inspections were undertaken.
- We maintained stores of sandbags at many of our rural villages for flood prevention and alleviation.
- 89 domestic properties and 24 commercial properties were flooded internally. Hundreds of visits were undertaken and over 6,000 sandbags were deployed across the district in December.
- We regularly inspect and clear debris from 34 screens to prevent storm/ floodwater flooding people's homes.
- We were consulted on 252 planning applications.



Clean Neighbourhoods

Our Clean Neighbourhoods team responded to a total of **835 callouts in 2015/16**.

These vary widely including flytipping (187 callouts), dog fouling (104 callouts), littering (58), abandoned vehicles (55), barking dogs (45), stray dogs (53), dangerous dogs (19), nuisance parking, smoke and fumes, various noise complaints and even a report of a dead animal needing disposal.

... and yes, the bins!

We provide a fortnightly refuse collection for all domestic properties in Craven. In addition, we also provide kerbside collections of paper and cardboard which is collected on alternate weeks to the refuse collection. Glass, cans and plastic bottles are collected every four weeks and garden waste is collected on a fortnightly basis. In 2015/16 we also started collecting beverage cartons as part of the recycling collection. We also provide a number of local recycling bring sites for residents across the district. These sites accept a wider range of materials including textiles. In addition, we run a garden waste collection service to which residents can subscribe for **£26 per year**; in 2015/16, a total of 8,709 properties across Craven had **9,065 garden waste licences**.

Street Cleansing

Verge patrols keep 1,717km of grass verges free of litter every year.

Street cleaners sweep **11,636km of streets** and road channels and sweep **5,469km of footpaths**.

On top of this, we empty **317 litter bins** and **201 dog bins** on varying frequencies dependent on their usage. We have nine Street Cleansing employees that keep all **550 square miles** of the district clean.

Council Finances

In February 2016 Craven District Council set its budget for the following year.

Councillors approved a £5 increase in Council Tax to £157.21 (band D). The increase came after five years of a Council Tax freeze.

Members also approved a net revenue budget of £7.896m for 2016/17. Council Tax will generate a total of £3.431m towards this budget.

Council Tax is collected by Craven District Council on behalf of the Council, Town and Parish Councils, the County Council, the Police and the Fire & Rescue Authorities.

Remember - not all of the Council Tax you pay is retained by this council.

Craven District Council will keep just £157.21 (£3.02 per week) of the £1,641.61 paid in Council Tax by a Craven household in 2016/17 to fund the services it provides (based on an average band D property Council Tax 16/17). The rest will go to North Yorkshire County Council, The Police & Fire Authorities and Parish/Town Councils.

Council Finances: The Challenge

Covernment grants, which used to make up a significant proportion of the Council's income, have been cut in the last few years and are set to further reduce going forward.

It is expected that the Revenue Support Grant will reduce to zero by 2019/20 and other grants will also be significantly reduced by the same year.

This means we will need to save £1,119,000 over the next 4 years to 2019/20. The savings target in 2017/18 will be £775,000 rising by £237,000 in 2018/19 to £1,012,000 and rising by a further £107,000 in 2019/20 to £1,119,000.

Despite the extensive cuts to Government funding we still aim to provide quality services for the people of Craven.

Some of our services are statutory - we have to provide them. These include services such as Environmental Health, Planning Services, taxi licensing, food premise inspections, cleaning the streets and collecting household waste and recycling.

Other services are discretionary - we choose to provide them. These services include Aireville Park in Skipton, Craven Pool & Fitness Centre and Craven Museum & Gallery.

Some of our services generate significant income for the Council which helps reduce the cost of providing them. These include car parking, Planning, Bereavement Services, Garden Waste collections and the Craven Pool & Fitness Centre.

North Yorkshire County Council provides other services which CDC does not. They include education and social services, libraries, transport and highways.

We listen to your views

Every year we hold a budget consultation asking residents questions about their priorities for spending over the next year. The latest budget consultation ends on November 4th, 2016. The Council's next budget will be set in February 2017.

So where exactly does your money go?
