

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The Craven District Council (Reorganisation of Community Governance) Order 2018

Made: 12th March 2018

Coming into force in accordance with article 1(2)

Craven District Council (the Council), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (the 2007 Act), has undertaken a community governance review and made decisions through the Policy Committee at a meeting held on 31st October 2017.

The Council has decided to give effect to those decisions and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors for the areas under review and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient.

The Council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section.

The Council makes the following Order in exercise of the powers conferred by sections 86 and 240 (10) of the 2007 Act.

Citation and commencement

1. (1) This Order may be cited as the Craven District Council (Reorganisation of Community Governance) Order 2018.
- (2) For the purposes of:
 - (a) this article; and
 - (b) proceedings preliminary or relating to the elections of parish councillors for the parishes set out in the Schedule

this Order shall come into force on the day after that on which it is made.

Interpretation

2. In this Order:

“district” means the district of Craven;

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983; and

“registration officer” means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the 2007 Act relevant to any provision of this Order.

Numbers of Parish Councillors for parish councils

4. (1) The numbers of parish councillors to be elected for each of the parishes shown in column (A) of the Schedule will be the numbers shown in column (C) of that Schedule in place of the existing number shown in column (B).
- (2) The effective date of election of the numbers of parish councillors shown in column (C) of the Schedule for the parishes listed in column (A) shall be the ordinary day of election of councillors for the year shown in column (D).

Electoral register


5. The registration officer for the District of Craven shall make such re-arrangement of, or adaptation to, the register of local government electors as may be necessary for the purposes of, and as a consequence of, this Order.

Order date

6. 12th March 2018 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.
