

# Explaining our budget 2019/20

In February the county council agreed on a series of budget recommendations which will allow us to carry on protecting and developing effective front-line services while also preparing for the challenges and unprecedented uncertainty of the years ahead.

Since 2010 our spending power has decreased significantly. Government funding has reduced and demand for services has increased. As a result, every £1 we had to spend on services at the start of the decade will have fallen to around 60p by the end of austerity.

In addition to a comprehensive savings plan county councillors also voted in February for an increase in general council tax of 2.99% along with a 2% social care precept, making a total of 4.99%. The overall 4.99% increase will be equivalent to just over £5 a month for an average household or £1.20p per week.

### What does the county council part of my council tax pay for?

The council tax bill you pay to your borough or district council contributes to the combined cost of county council, district/borough council, parish council, police and fire services.

For the county council that includes services such as schools, adult social care, roads, street lighting, winter maintenance, disposal of waste collected by borough and district councils, libraries and emergency planning. The combined cost of the services we provide as a county council will be £1 billion in 2019/20.

### How is the county council element of my council tax calculated?

All households have a property band between A and H, which is allocated based on the value of the property. The amount you pay depends on which band your home is in.

There are two elements to the council tax which pays for county council services, the main council tax and the adult social care precept. The 4.99% overall increase for 2019/20 is made up of a 2.99% general increase and a 2% adult social care precept.



#### The table below shows how much of the council tax you pay goes to the county council.

#### What is the adult social care precept for?

The adult social care (ASC) precept came into effect in 2016/17. It is a portion of council tax which is set aside specifically for adult social care services. The council currently supports 8,491 older people and younger adults, including people with learning disabilities, physical disabilities and mental ill health, as well as their carers. Adult social care services are delivered in a number of different ways including prevention and supporting people to live independently in their own homes as well as residential and nursing care.

We spend almost £250m on adult social care services every year, supporting people to live longer, healthier, more independent lives. We currently receive over 77,000 enquiries every year relating to adult social care and demand for services is increasing.

### How is the adult social care precept calculated?

The adult social care precept is calculated as 2% of the total of the previous year's council tax which went to the county council. It is then added to the previous year's adult social care precept amount as shown in the example below for a band D property.

The precept percentage increase above is calculated based on the total North Yorkshire County Council charge in 2018/19 (i.e. £1,248.85) so:  $£1,248.85 \times 2\% = £24.97$ 

£68.67 (2018/19 cumulative adult social care precept) + £24.97 (2019/20 increase in adult social care precept) = £93.64

## Why should I have to pay council tax and an ASC precept when I don't use any services from the county council?

Although everyone benefits from some county council services such as highways and transport, only those with children will receive education support and most people would like to remain sufficiently independent and healthy so that they never need council support such as residential care. However, it is often these statutory services which benefit the smaller number of people that cost the most. Similarly, the adult social care precept is part of council tax rather than a service charge and not linked to whether or not you receive social care services. You could think of council tax as an insurance premium. You hope you will never have to claim but you have the comfort of knowing that if you, or a member of your family, need to then there will be support to help you.
