Designation of officers


In accordance with regulation 18(11)(a)(iv) of the first set of regulations and regulations 10(6)(d) and 12(12) of the second set of regulations, Craven District Council ('the Council') hereby designates the officers named below as authorised persons to enforce the provisions of the regulations and to issue fixed penalty notices, to the extent set out in the regulations.

This designation includes any amendment or addition to the regulations, any regulations of similar or wider effect and any regulations that replace SI 2020/1005 or SI 2020/1045 (with or without re-enactments).

This designation supplements the provision made by regulation 17 of the second set of regulations, that a person who is designated for the purposes of regulation 9(13) or 10 of the Health Protection (Coronavirus, Restrictions) (No. 2) (England) Regulations 2020 is to be treated as if they were designated for the purposes of regulations 10(6) and 12(12) of the second set of regulations.

For the purposes of the first set of regulations, this designation supersedes any designation by or on behalf of North Yorkshire County Council with immediate effect, recognising that the officers are employed as officers of Craven District Council for the purposes of discharging functions of the District Council.

Officers listed below are hereby authorised to exercise any function allocated to a local authority (at district council level) under the Second Lockdown Regulations on behalf of the Council including but not exclusive to taking any actions in relation to the issue, administration and enforcement of Fixed Penalty Notices under regulation 21 thereof.
